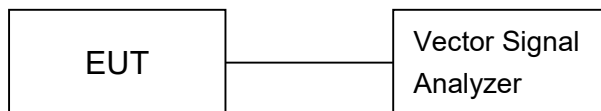

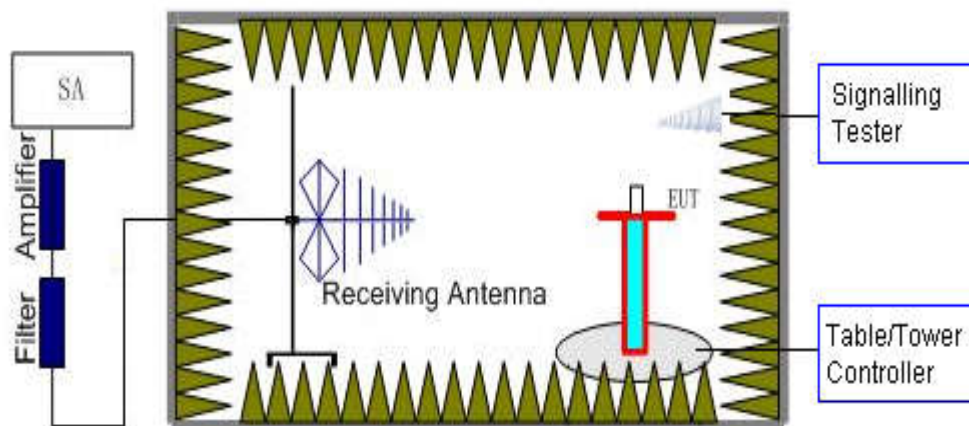
1) Conducted Measurements

1. Connect the EUT to the test system correctly.
2. Set the EUT to the required work mode.
3. Set the EUT to the required channel.
4. Set the spectrum analyzer to start measurement.
5. Record the values.



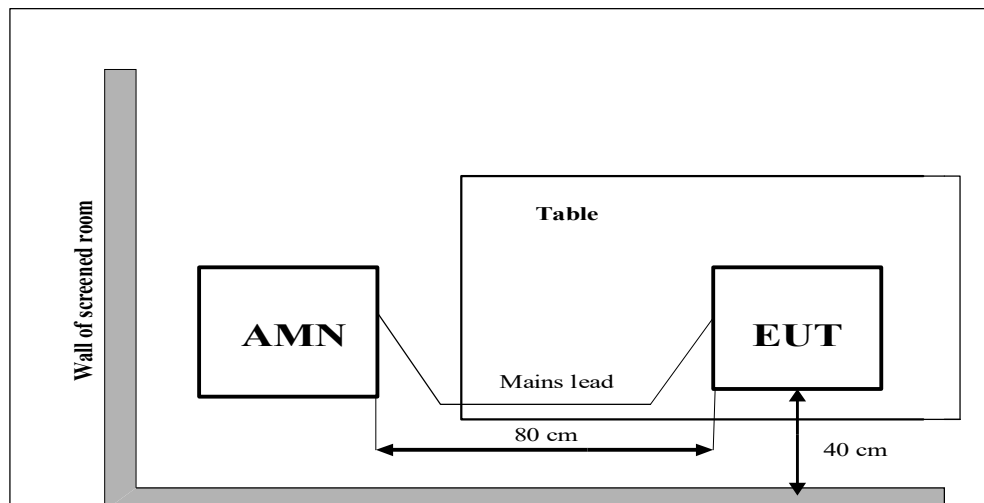
2) Radiated Measurements

Test setup: EUT was placed on a 1.5 meter high non-conductive table at a 3 meter test distance from the receive antenna. The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the EUT and adjusting the receiving antenna polarization.



3) AC Power line Conducted Emission Measurement

For Bluetooth LE, the EUT is working under test mode. The EUT is commanded to operate at maximum transmitting power.





A.0 Antenna requirement

Measurement Limit:

FCC CRF Part 15.203	An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of §15.211, §15.213, §15.217, §15.219, or §15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with §15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this part are not exceeded.

Conclusion: The Directional gains of antenna used for transmitting is -1.0 dBi.

The RF transmitter uses an integrate antenna without connector.

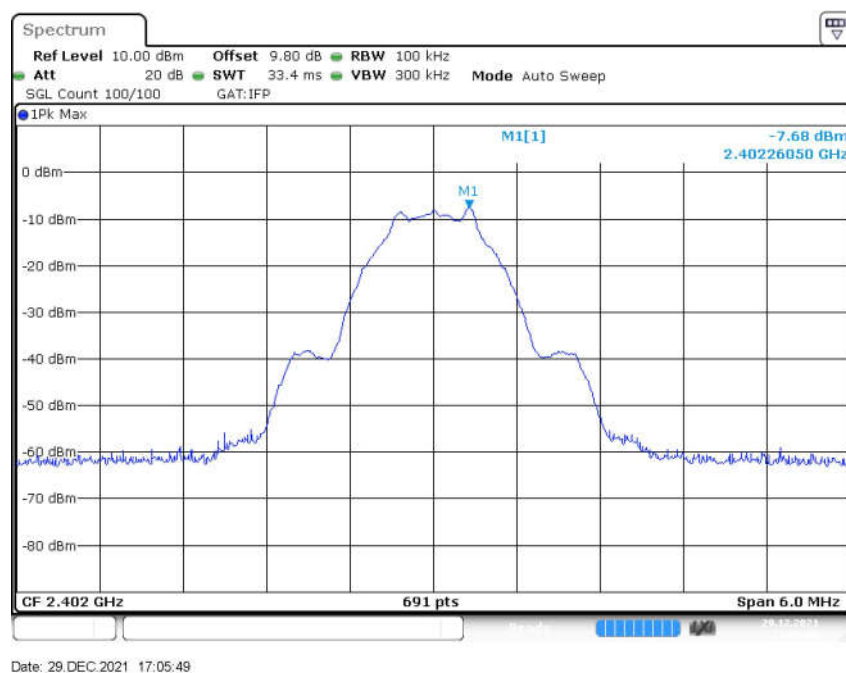


Fig.1 Power Spectral Density (Ch 0), LE 1M

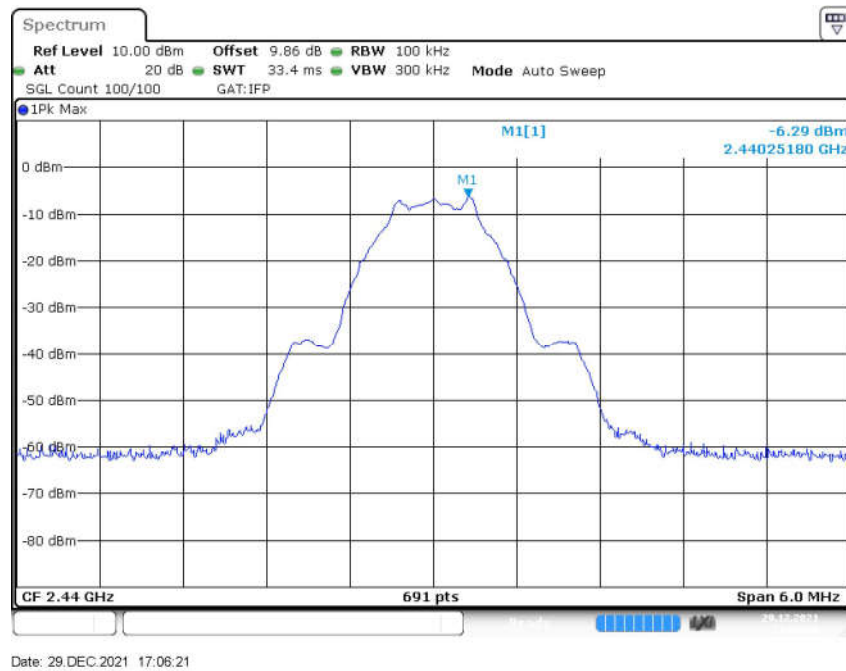


Fig.2 Power Spectral Density (Ch 19), LE 1M

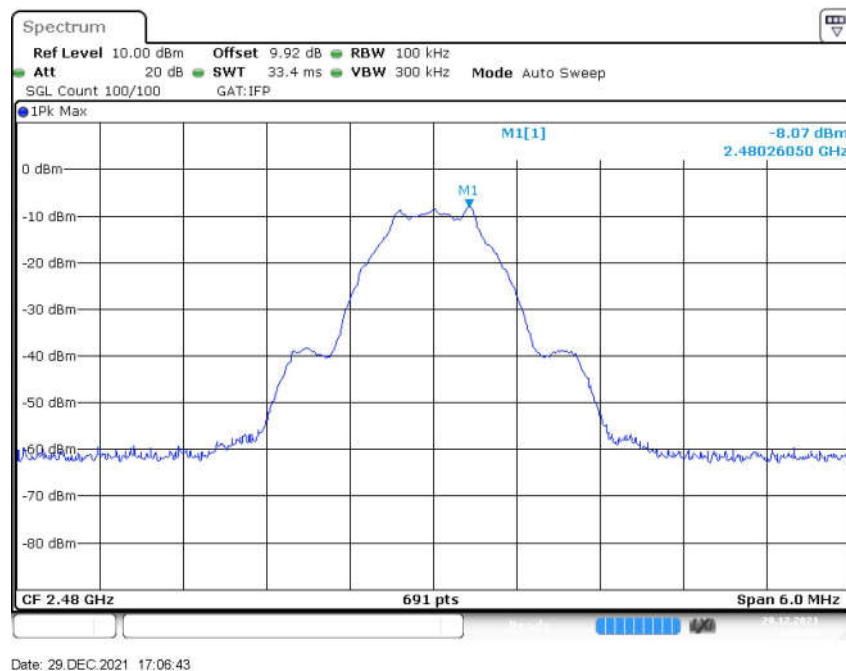


Fig.3 Power Spectral Density (Ch 39), LE 1M

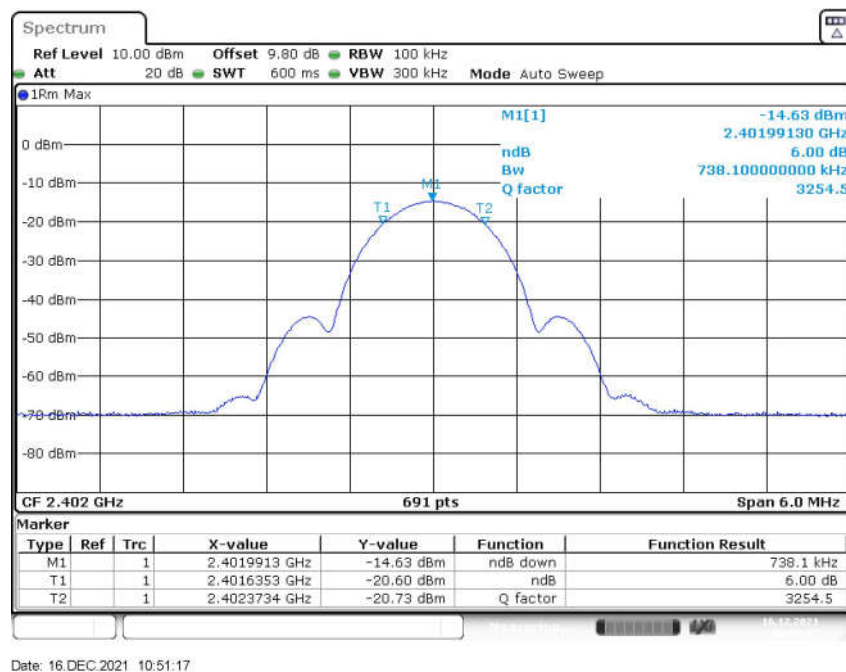


Fig.4 6dB Bandwidth (Ch 0), LE 1M

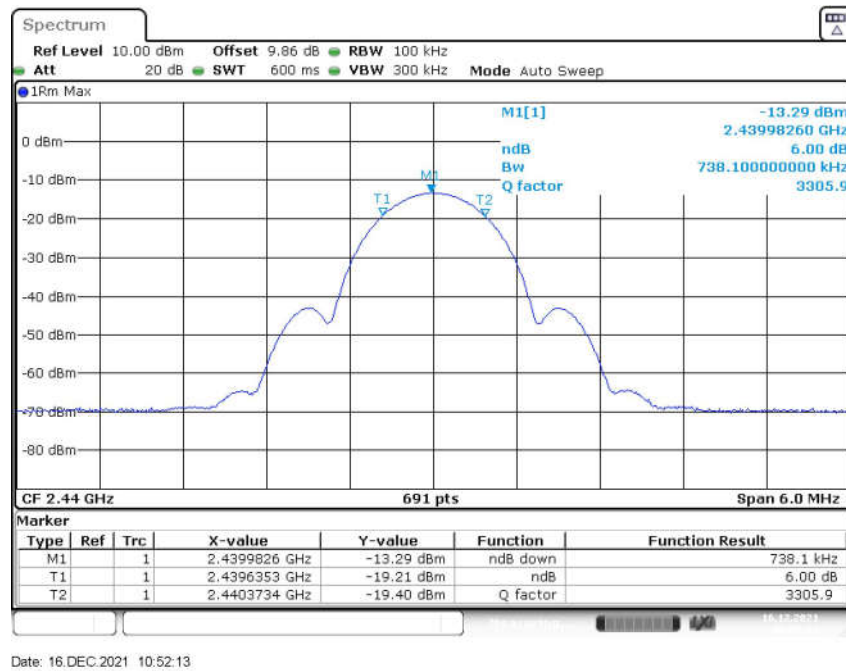


Fig.5 6dB Bandwidth (Ch 19), LE 1M

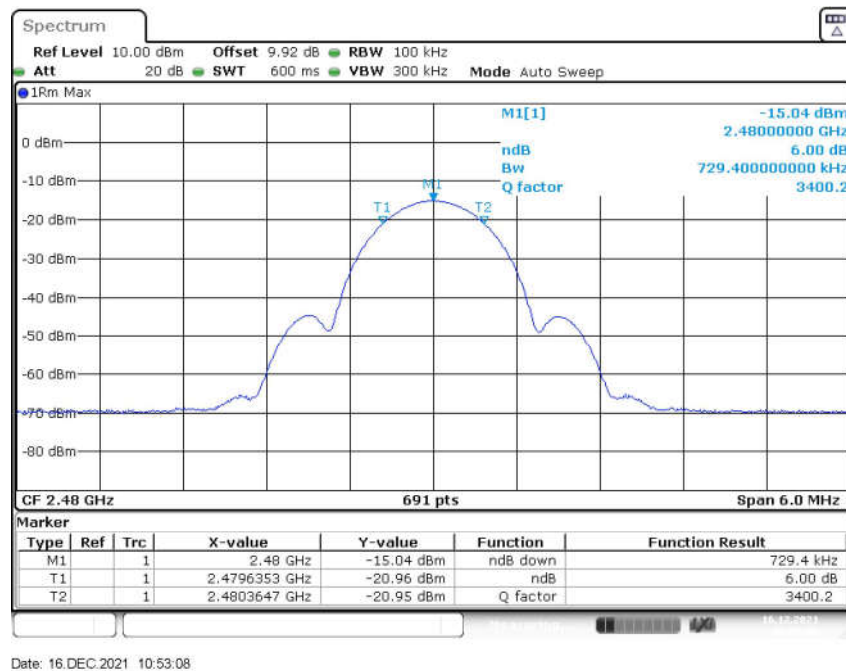


Fig.6 6dB Bandwidth (Ch 39), LE 1M

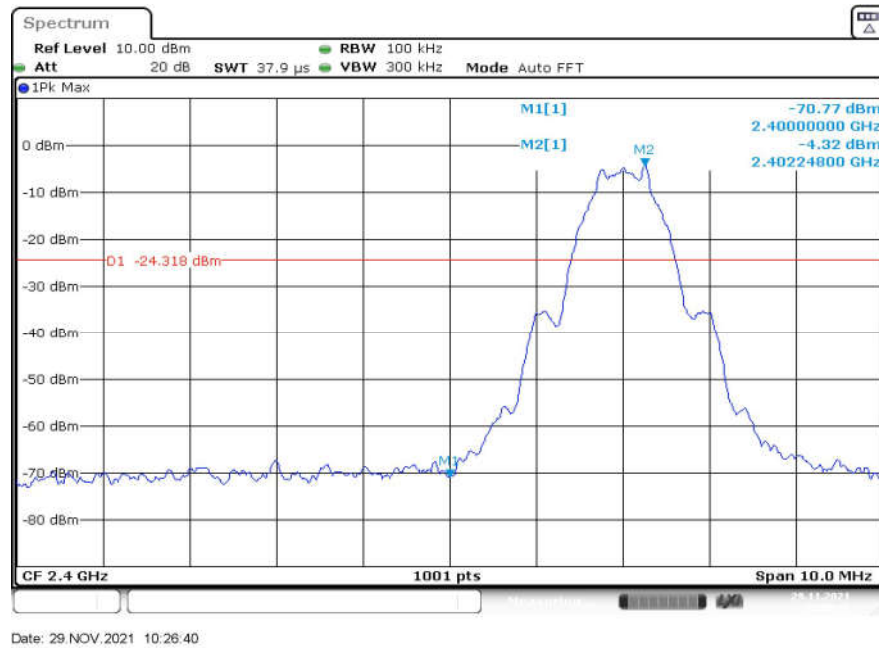


Fig.7 Band Edges (Ch 0), LE 1M

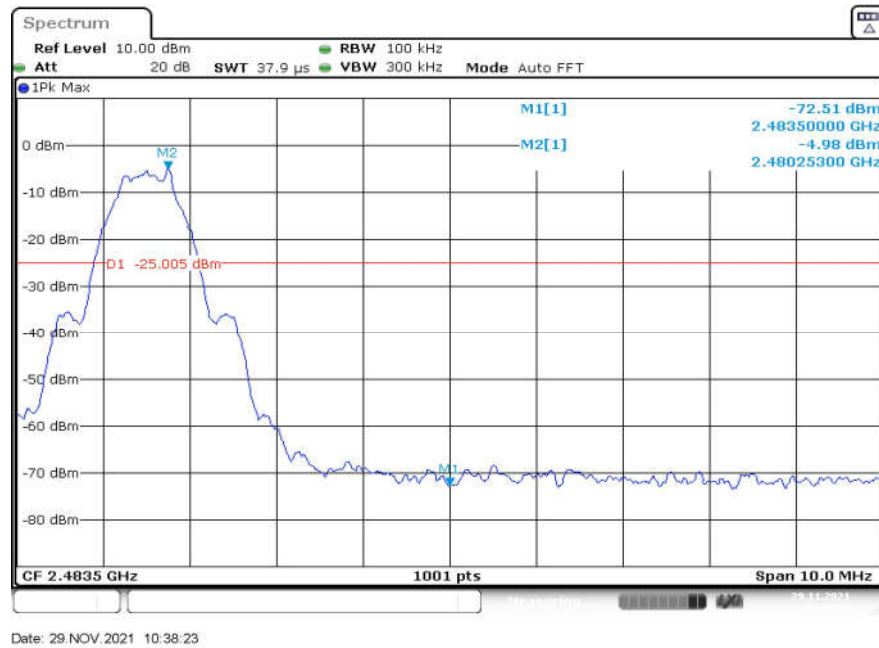


Fig.8 Band Edges (Ch 39), LE 1M

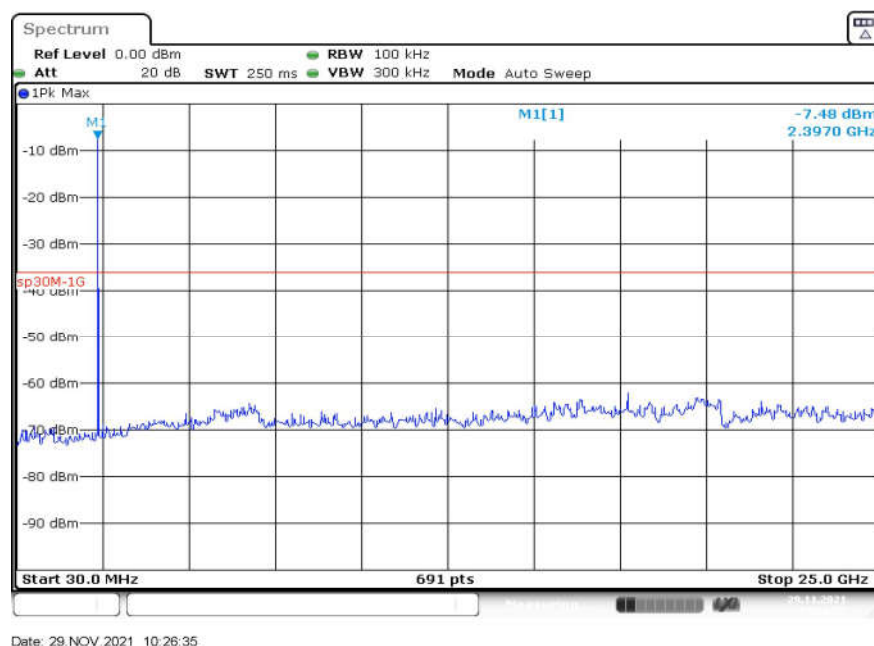


Fig.9 Conducted Spurious Emission (Ch0, 30 MHz-26.5 GHz), LE 1M

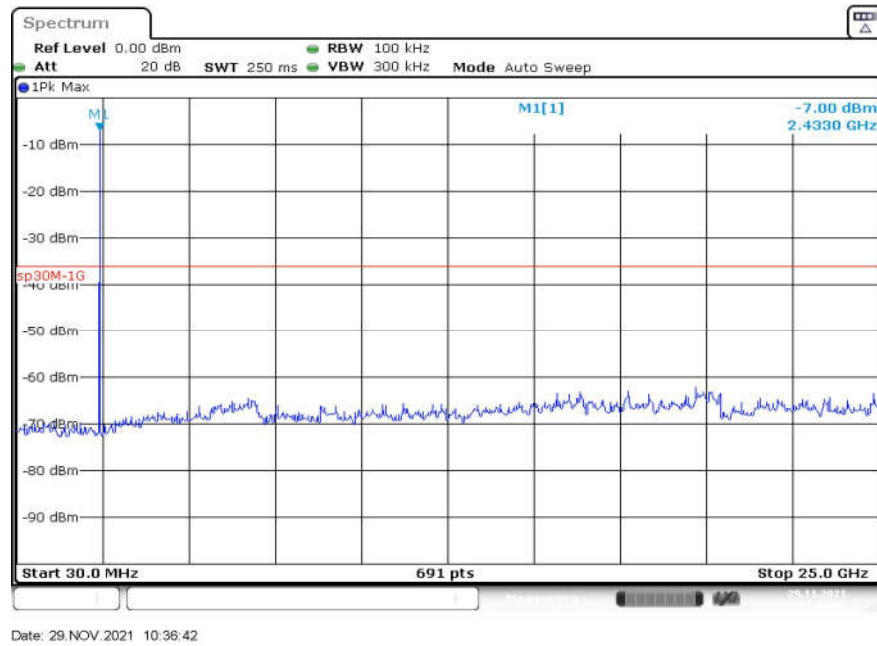


Fig.10 Conducted Spurious Emission (Ch19, 30 MHz-26.5 GHz), LE 1M

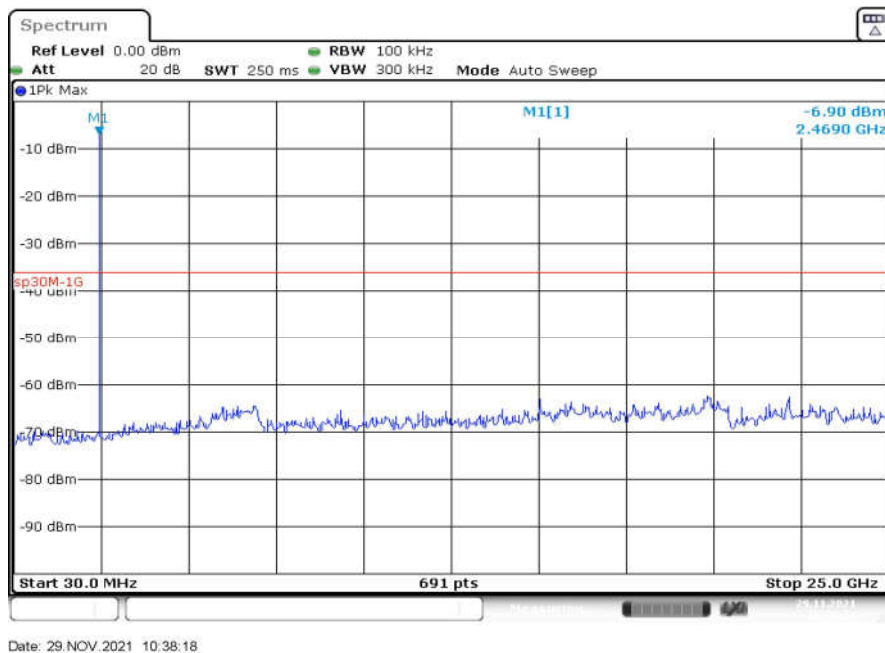


Fig.11 Conducted Spurious Emission (Ch39, 30 MHz-26.5 GHz), LE 1M

The EUT was placed on a non-conductive table. The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and the EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. This maximization process was repeated with the EUT positioned in each of its three orthogonal orientations.

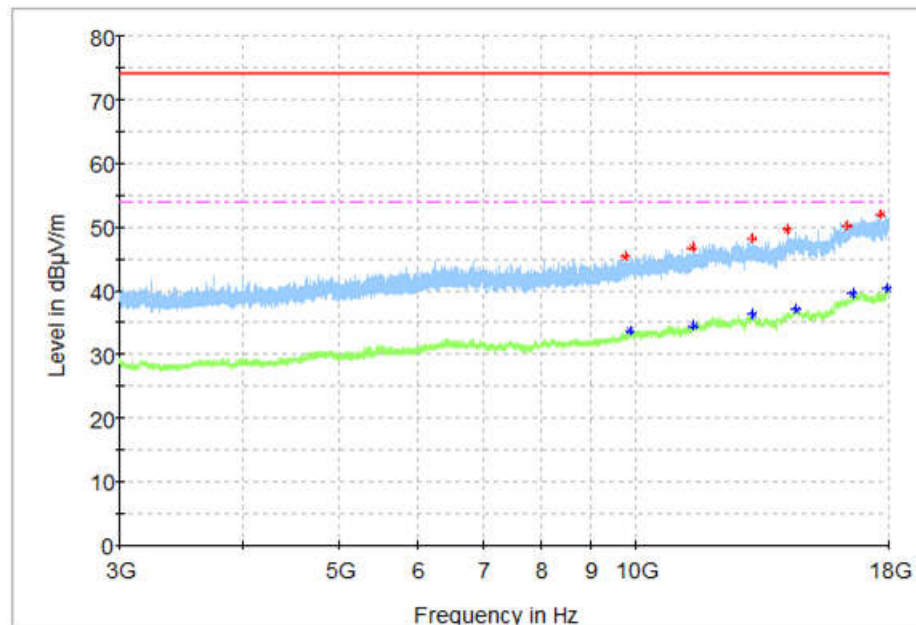


Fig.12 Radiated Spurious Emission (Ch0, 3 GHz ~18 GHz), LE 1M

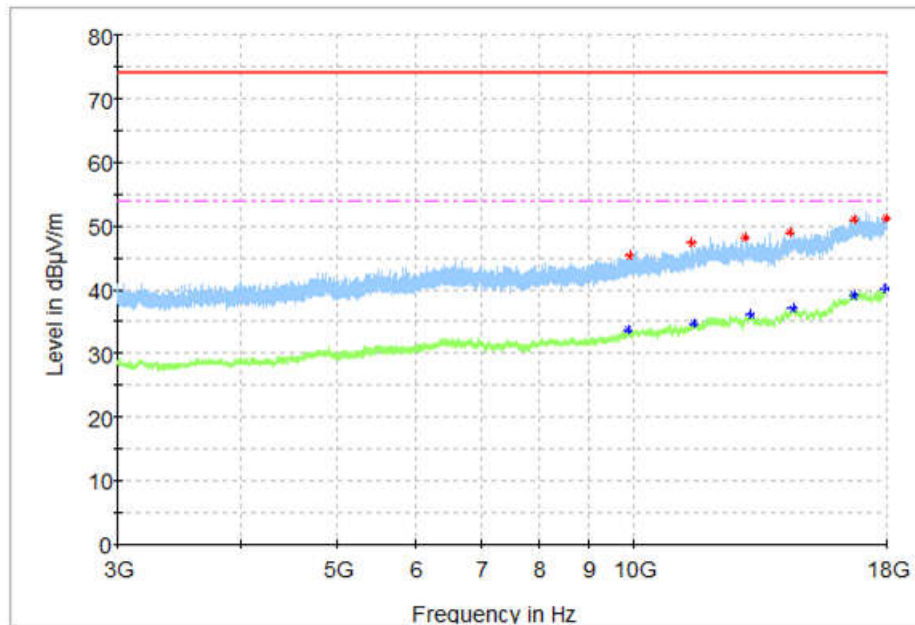


Fig.13 Radiated Spurious Emission (Ch19, 3 GHz ~18 GHz), LE 1M

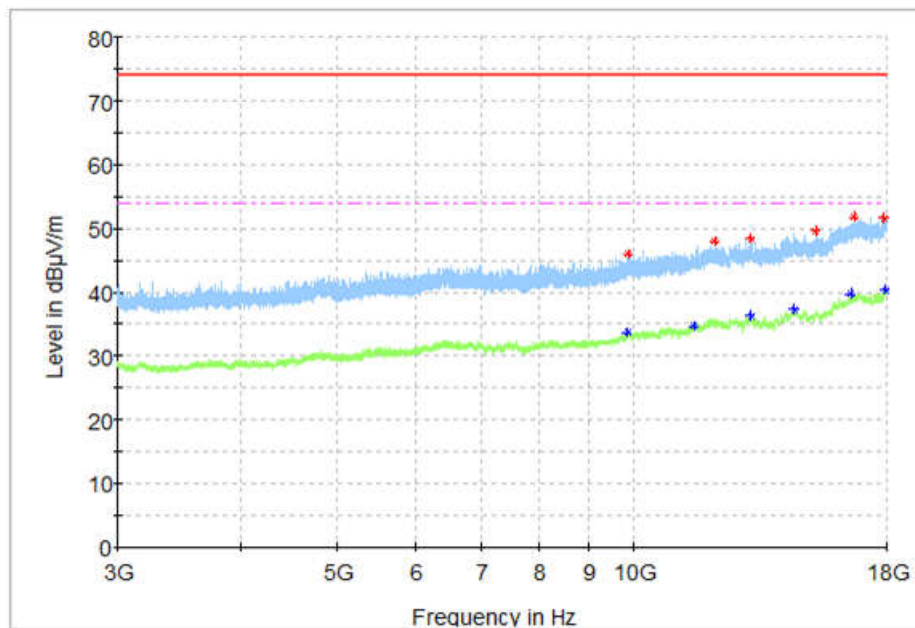


Fig.14 Radiated Spurious Emission (Ch39, 1 GHz ~18 GHz), LE 1M

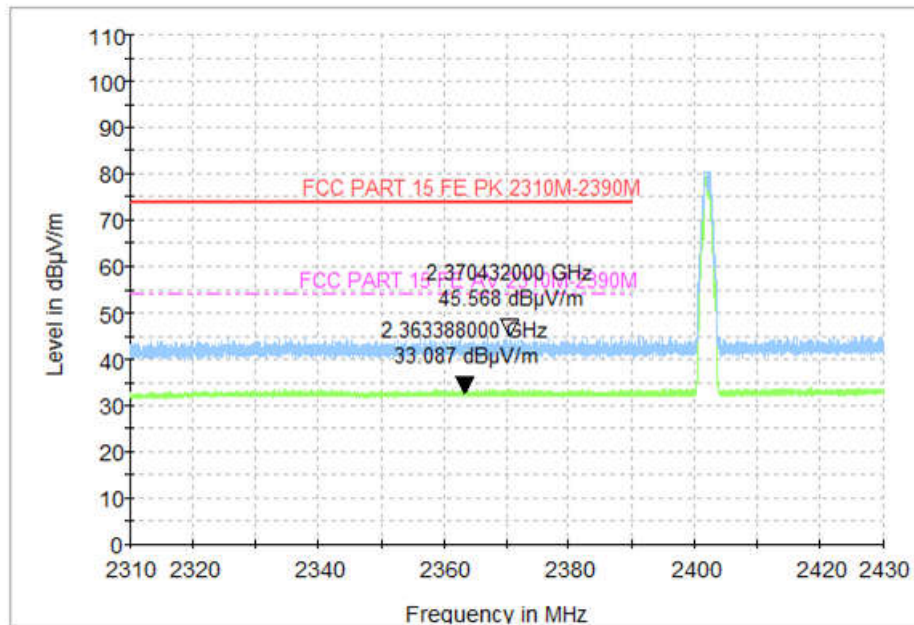


Fig.15 Radiated Band Edges (Ch0, 2380GHz~2450GHz), LE 1M

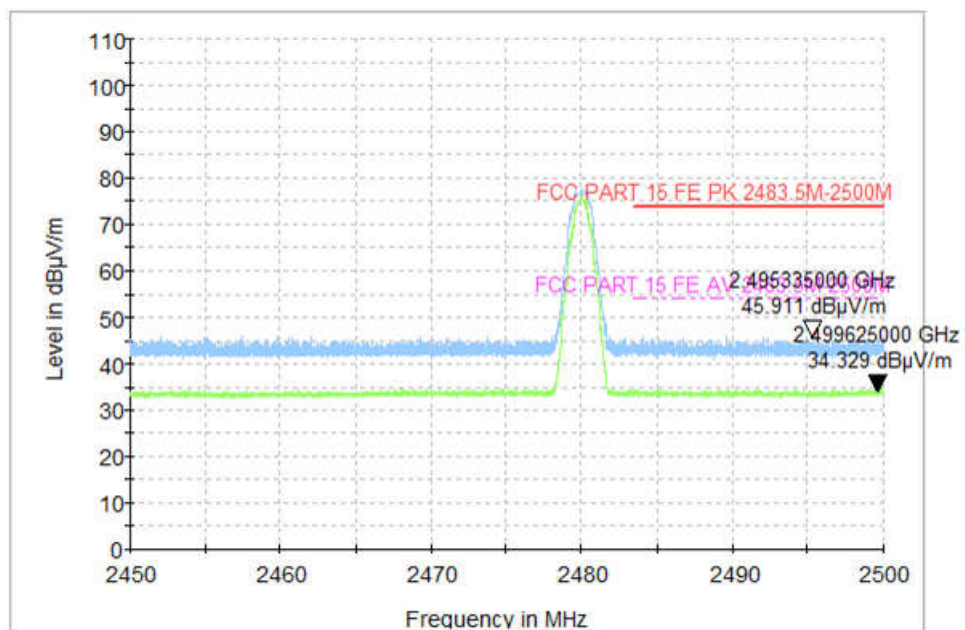


Fig.16 Radiated Band Edges (Ch39, 2450GHz~2500GHz), LE 1M

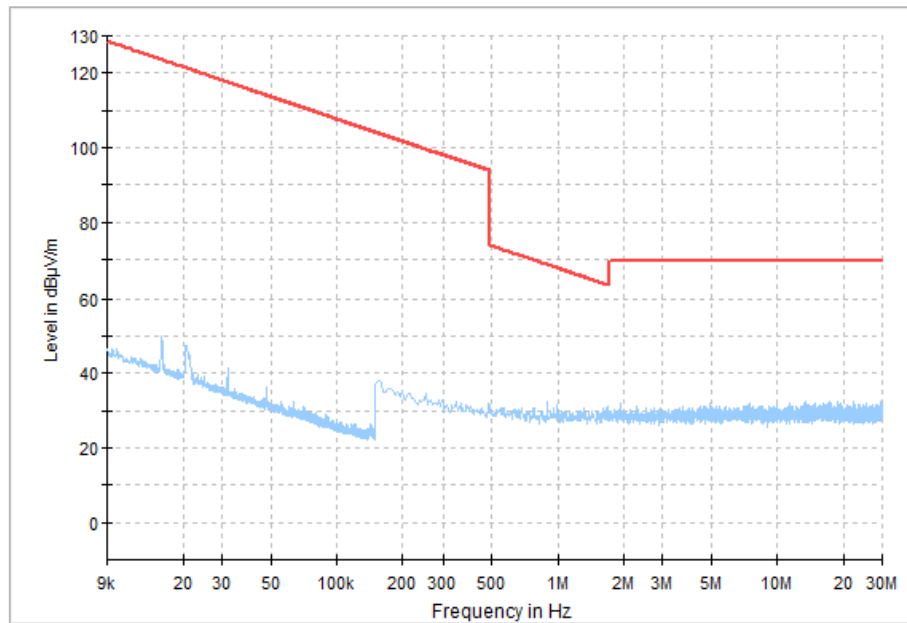


Fig.17 Radiated Spurious Emission (All Channels, 9 kHz-30 MHz), LE

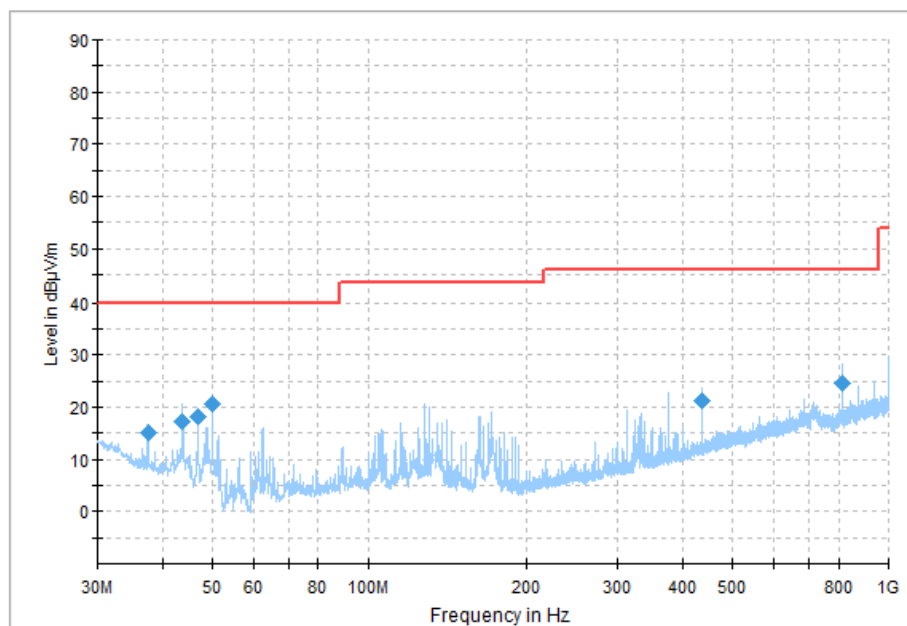


Fig.18 Radiated Spurious Emission (All Channels, 30 MHz-1 GHz), LE

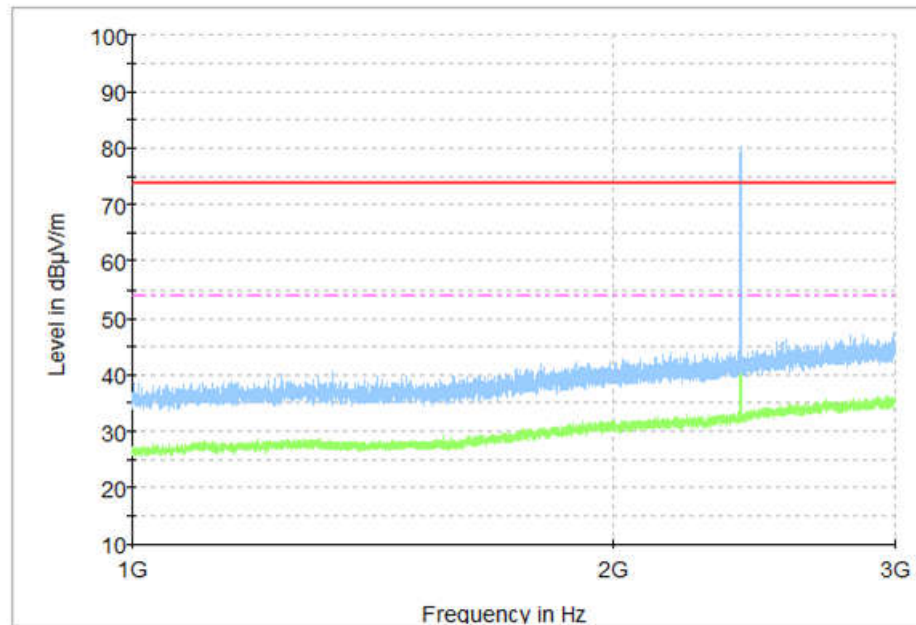


Fig.19 Radiated Spurious Emission (All Channels, 1 GHz-3 GHz), LE

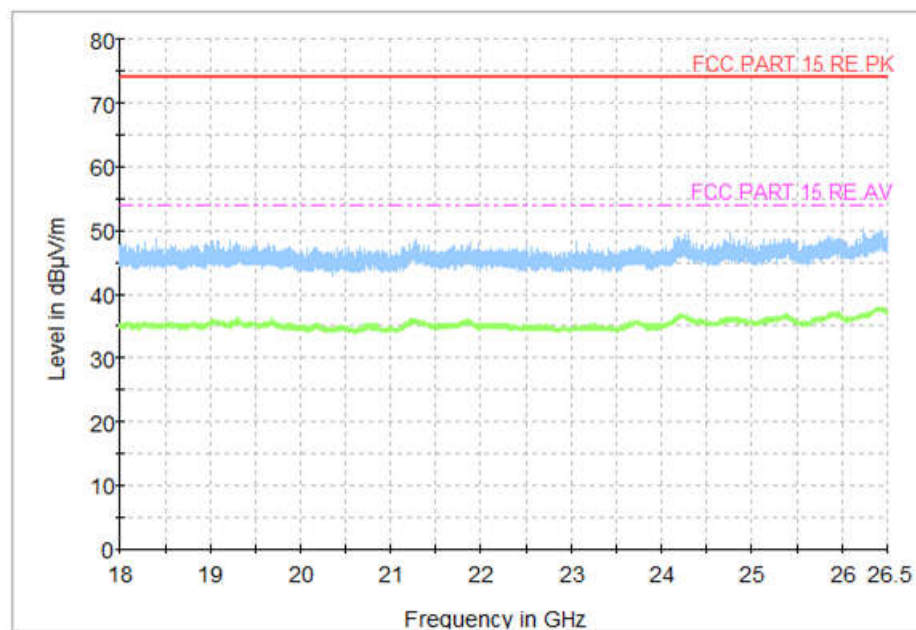


Fig.20 Radiated Spurious Emission (All Channels, 18 GHz-26.5 GHz), LE

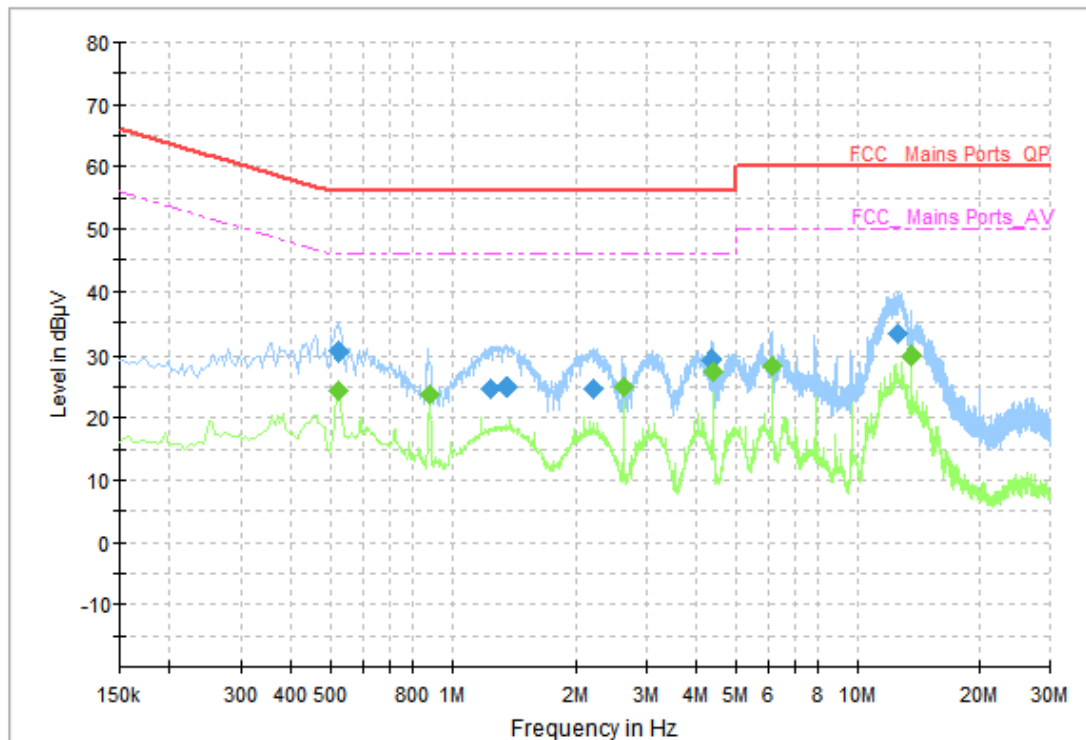


Fig.21 AC Power line Conducted Emission (Traffic), LE

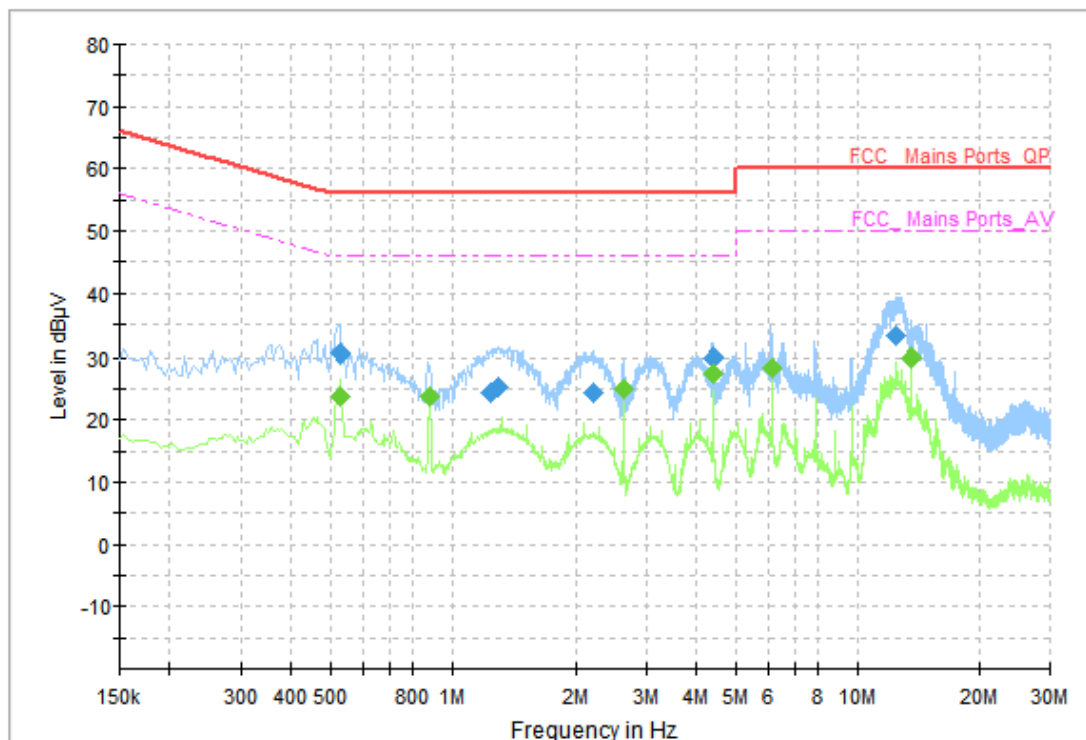


Fig.22 AC Power line Conducted Emission (Idle), LE
