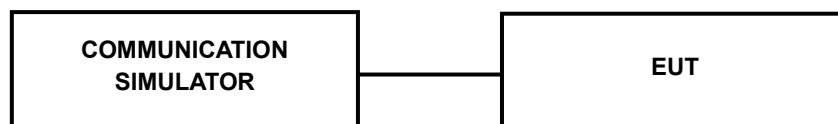

Rotated the Turn Table and moved receiving antenna to find the maximum radiation power. Adjust output power level of S.G to get a Value of spectrum reading equal to “Read Value” of step a. Record the power level of S.G
- c. $\text{EIRP} = \text{Output power level of S.G} - \text{TX cable loss} + \text{Antenna gain of substitution horn}.$
- d. E.R.P power can be calculated form E.I.R.P power by subtracting the gain of dipole,
 $\text{E.R.P power} = \text{E.I.P.R power} - 2.15\text{dBi}.$

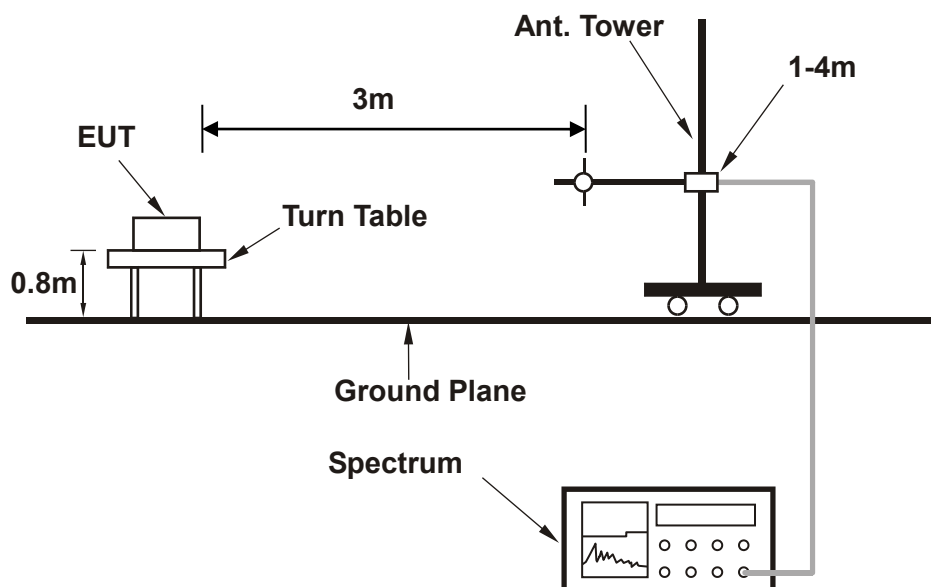
