Note 1: The EUT is a Smartphone, it contains Bluetooth Module operating at 2.4GHz ISM band; the frequencies allocated for the Bluetooth Module is $F(\text{MHz})=2402+1*n$ ($0 \leq n \leq 78$). The lowest, middle, highest channel numbers of the Bluetooth Module used and tested in this report are separately 0 (2402MHz), 39 (2441MHz) and 78 (2480MHz).

Note 2: For a more detailed description, please refer to Specification or User's Manual supplied by the applicant and/or manufacturer.

Note 3: a. When power on, the EUT will scan the whole frequency until a Connection command from the other BT devices.

b. When receiving the signal from the other BT devices, The EUT transmit a response signal.

c. The other devices receive the response signal and recognize it, then send a connection command to establish the connection.

d. After the connection establish successfully, the data transmission is beginning. At the same time, the both devices will shift frequencies in synchronization per a same pseudo randomly ordered list of hopping frequencies, the hopping rate is 1600 times per second. This device conforms to the criteria in FCC Public Notice DA 00-705.

e. The bandwidth of the receiver, which is set to a fixed width by the software.

Note 4: Bluetooth signal has 9 packages 1DH1, 1DH3, 1DH5, 2DH1, 2DH3, 2DH5, 3DH1, 3DH3, 3DH5, DH5 package is largest, we are testing DH5 in the document.

According to FCC 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

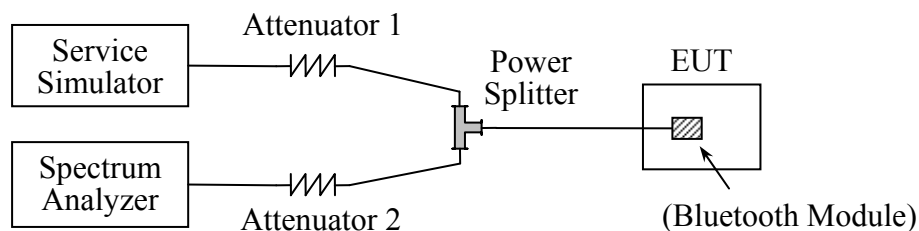
2.2. Number of Hopping Frequency

2.2.1. Requirement

According to FCC §15.247(a)(1)(iii), frequency hopping systems operating in the 2400MHz to 2483.5MHz bands shall use at least 15 hopping frequencies.

The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

(Plot C: 8- DPSK)

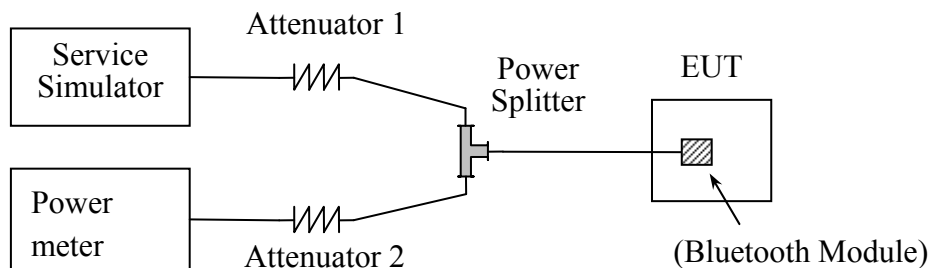
2.3. Peak Output Power

2.3.1. Requirement

According to FCC §15.247(b)(1), for frequency hopping systems that operates in the 2400MHz to 2483.5MHz band employing at least 75 hopping channels, the maximum peak output power of the intentional radiator shall not exceed 1Watt. For all other frequency hopping systems in the 2400MHz to 2483.5MHz band, it is 0.125Watts.

A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Power meter and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

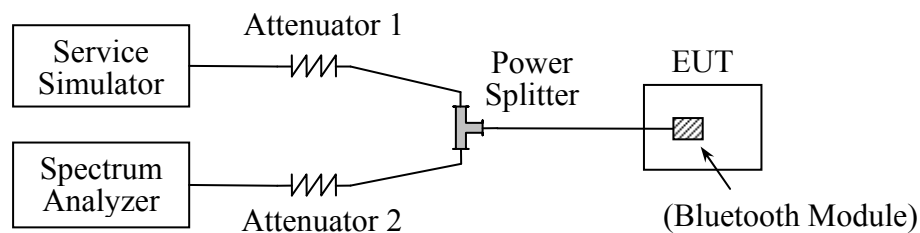
2.4. 20dB Bandwidth

2.4.1. Definition

According to FCC §15.247(a)(1), the 20dB bandwidth is known as the 99% emission bandwidth, or 20dB bandwidth ($10 \cdot \log 1\% = 20\text{dB}$) taking the total RF output power.

A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50 Ohm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

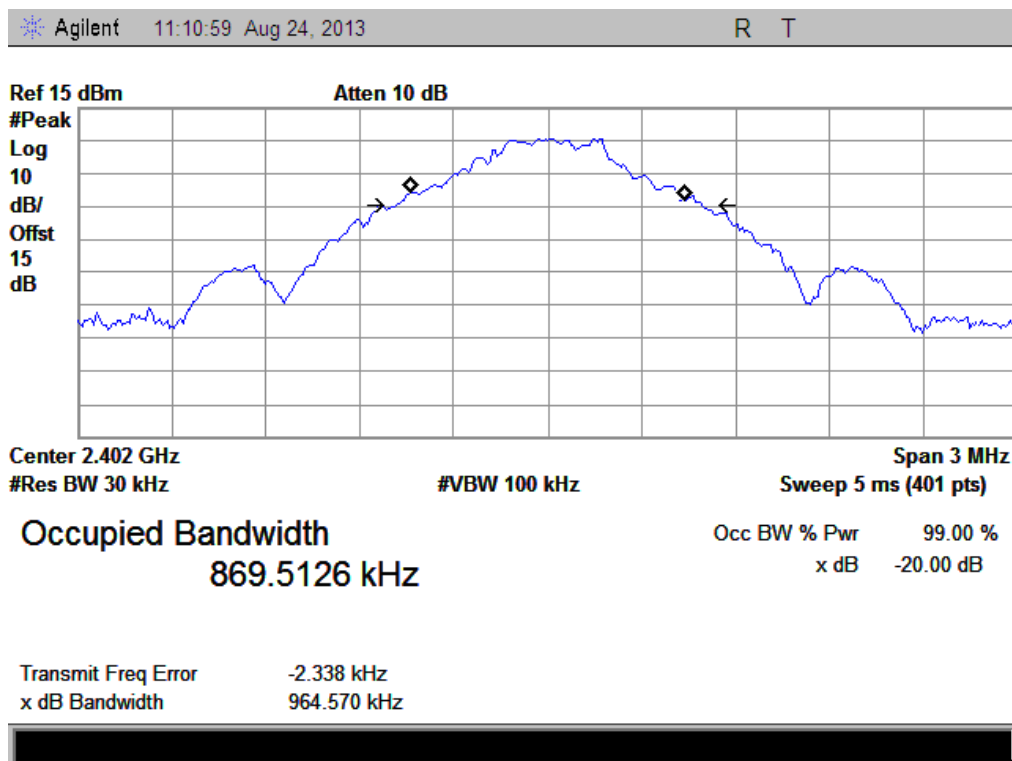

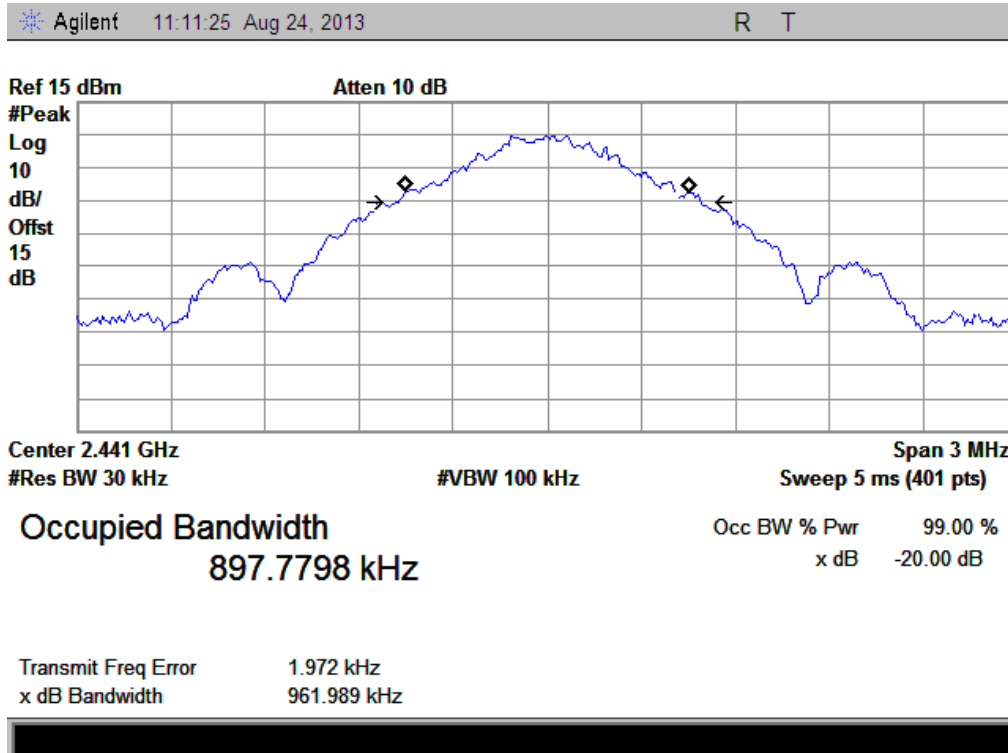

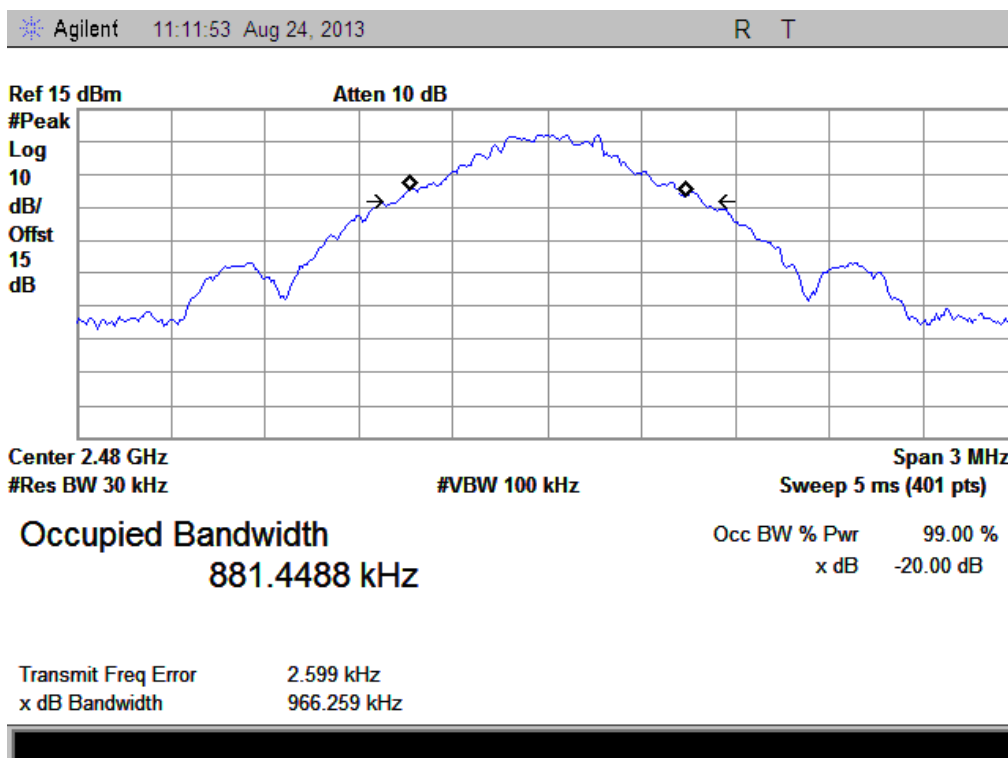

(Plot C: Channel = 2480 @ GFSK)

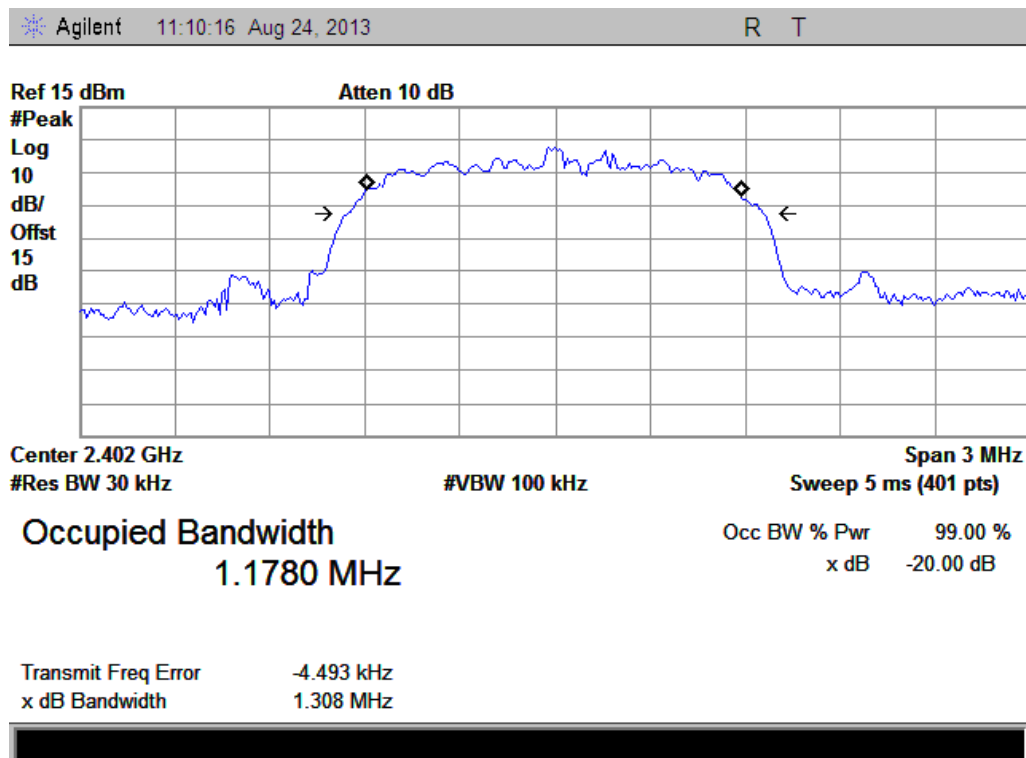

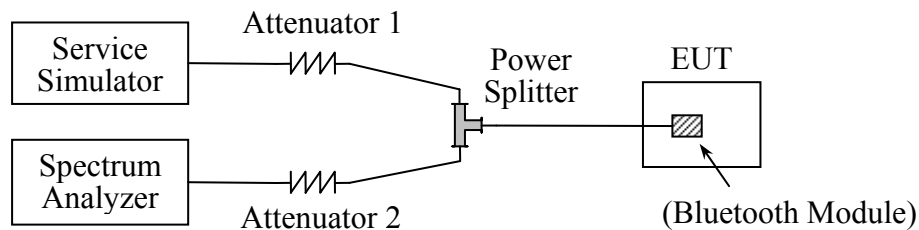
2.5. Carried Frequency Separation

2.5.1. Definition

According to FCC §15.247(a)(1), frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25kHz or two-thirds of the 20dB bandwidth of the hopping channel, whichever is greater.

2.5.2. Test Description

A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

2.5.3. Test Procedure

The EUT must have its hopping function enabled. Use the following spectrum analyzer settings:

Span = wide enough to capture the peaks of two adjacent channels

Resolution (or IF) Bandwidth (RBW) $\geq$ 1% of the span

Video (or Average) Bandwidth (VBW) $\geq$ RBW

Sweep = auto

Detector function = peak

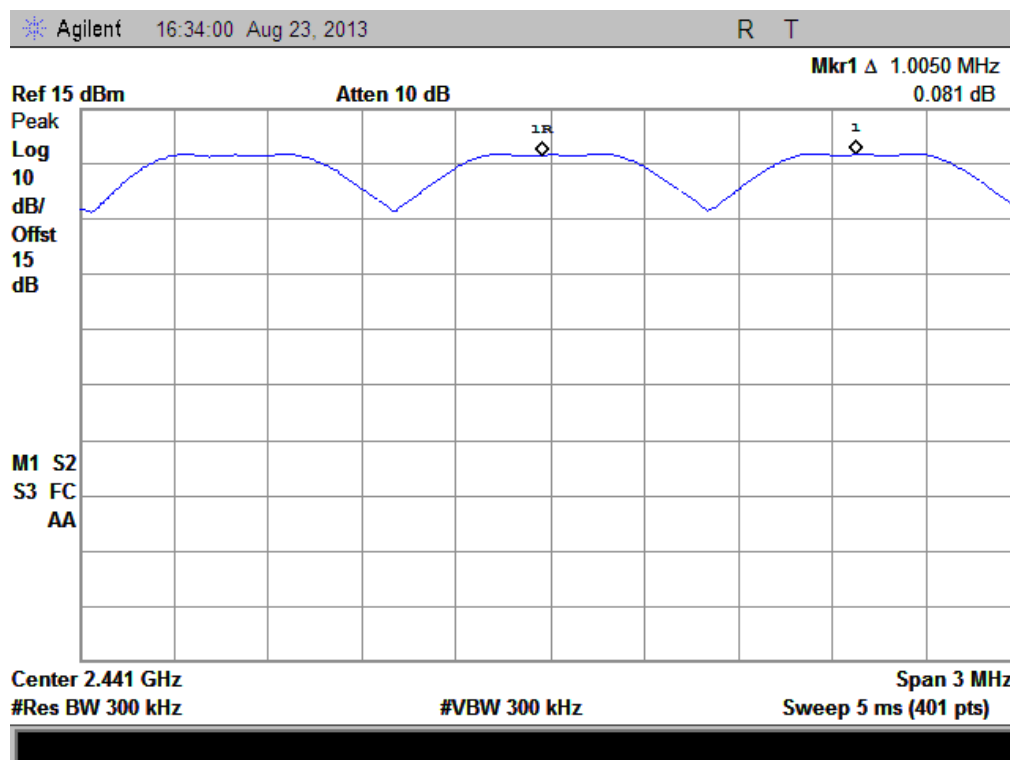
Trace = max hold

Allow the trace to stabilize. Use the marker-delta function to determine the separation between the peaks of the adjacent channels.

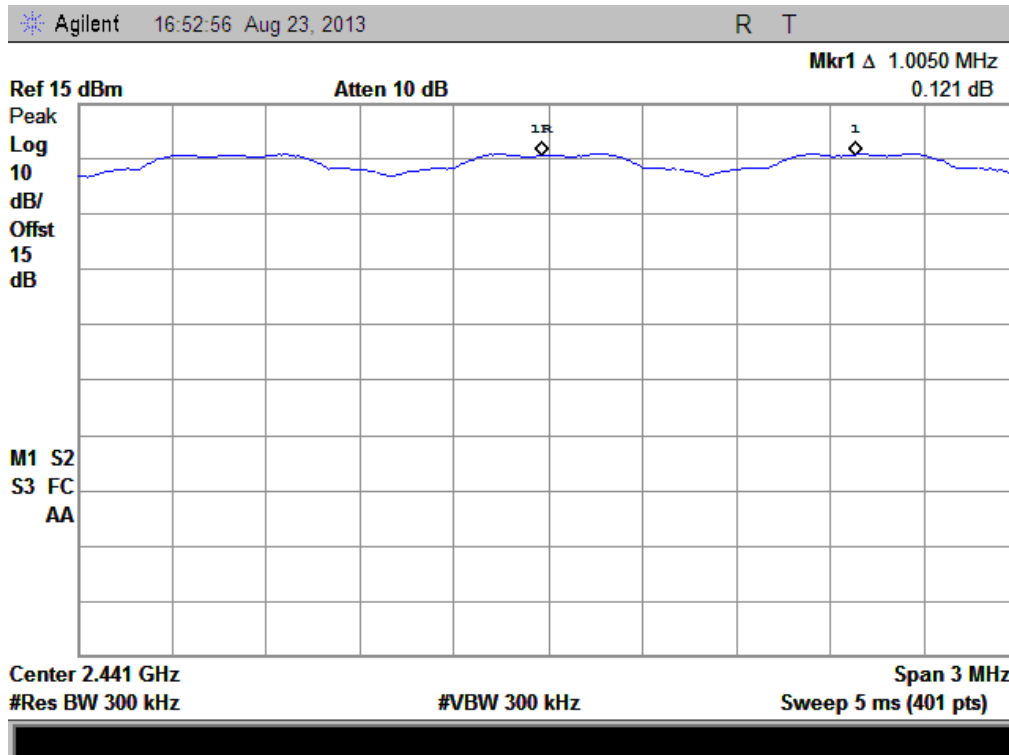
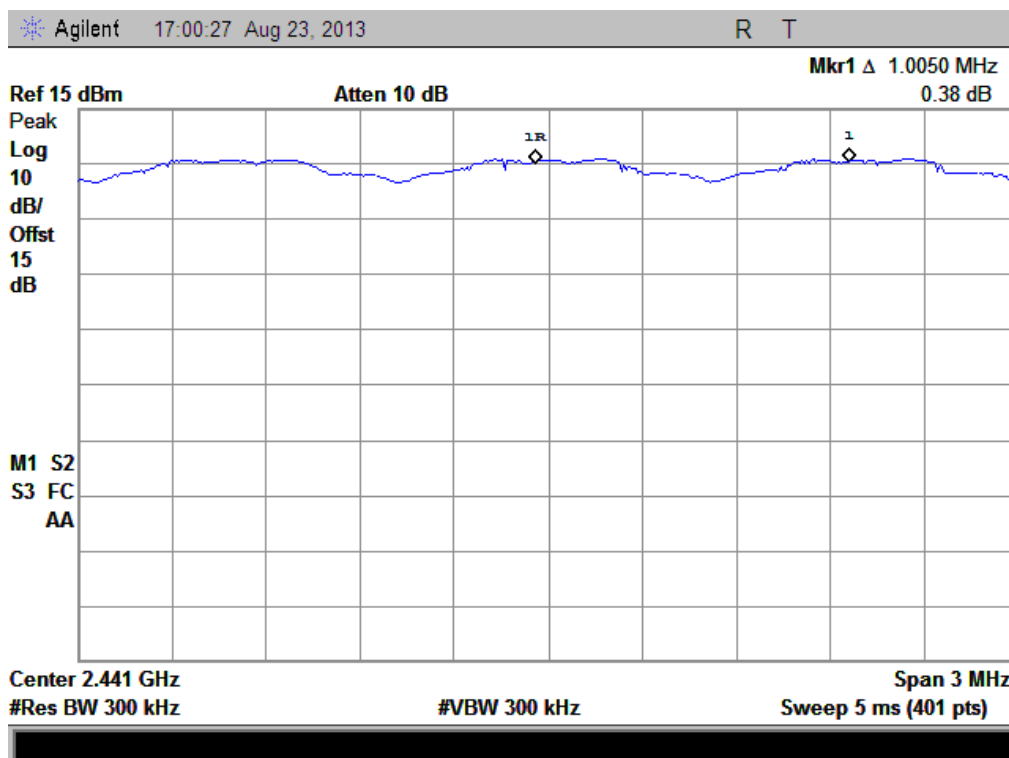
2.5.4. Test Result

The Bluetooth Module operates at hopping-on test mode.

For any adjacent channels (e.g. the channel 39 and 40 as showed in the Plot A), the Module does have hopping channel carrier frequencies separated by a minimum of 25kHz or two-thirds of the 20dB bandwidth of the hopping channel (0.9663MHz for GFSK mode, 1.3080MHz for $\pi/4$ -DQPSK mode and 1.3010MHz for 8-DPSK mode, refer to section 2.4.1), whichever is greater. So, the verdict is PASSING

(Plot C: 8-DPSK)

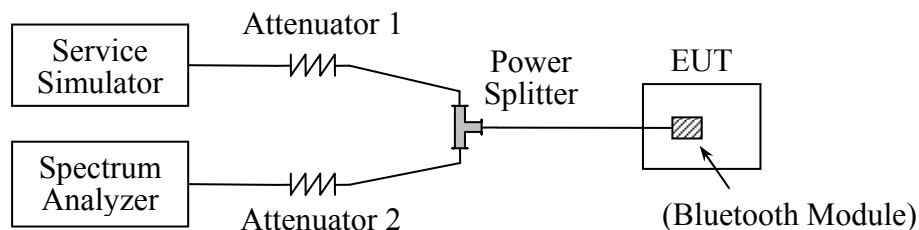
2.6. Time of Occupancy (Dwell time)

2.6.1. Requirement

According to FCC §15.247(a) (1) (iii), frequency hopping systems in the 2400 - 2483.5MHz band shall use at least 15 non-overlapping channels. The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed. Frequency hopping systems may avoid or suppress transmissions on a particular hopping frequency provided that a minimum of 15 channels are used.

The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. During the measurement, the Bluetooth Module of the EUT is activated and controlled by the SS, and is set to operate under test mode transmitting 339 bytes DH5 packages at maximum power.

2.6.3. Test Procedure

The transmitter output is connected to a spectrum analyzer. The span is set to 0 Hz, centered on a single, selected hopping channel. The width of a single pulse is measured in a fast scan. The number of pulses is measured in a 3.16 second scan, to enable resolution of each occurrence.

The average time of occupancy in the specified 31.6 second period (79 channel * 0.4 s) is equal to $10 * (\text{\# of pulses in 3.16 s}) * \text{pulse width}$.

For AFH mode, the average time of occupancy in specified 8 second period (20 channel * 0.4 s) is equal to $10 * (\text{\# of pulses in 0.8 s}) * \text{pulse width}$.

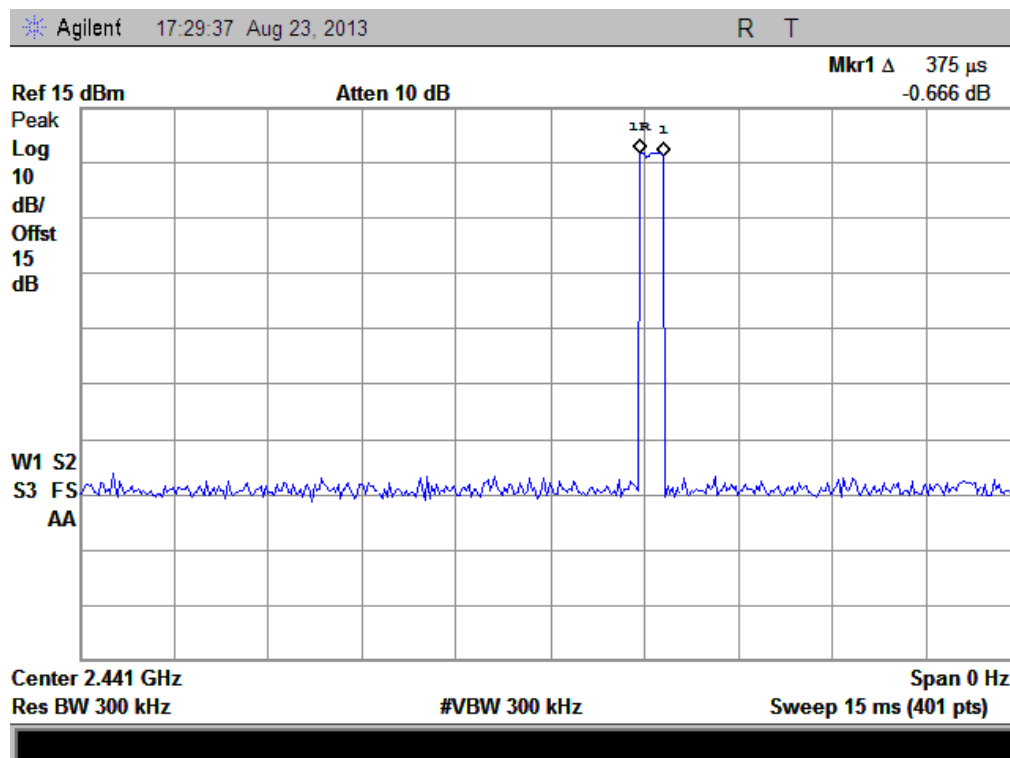

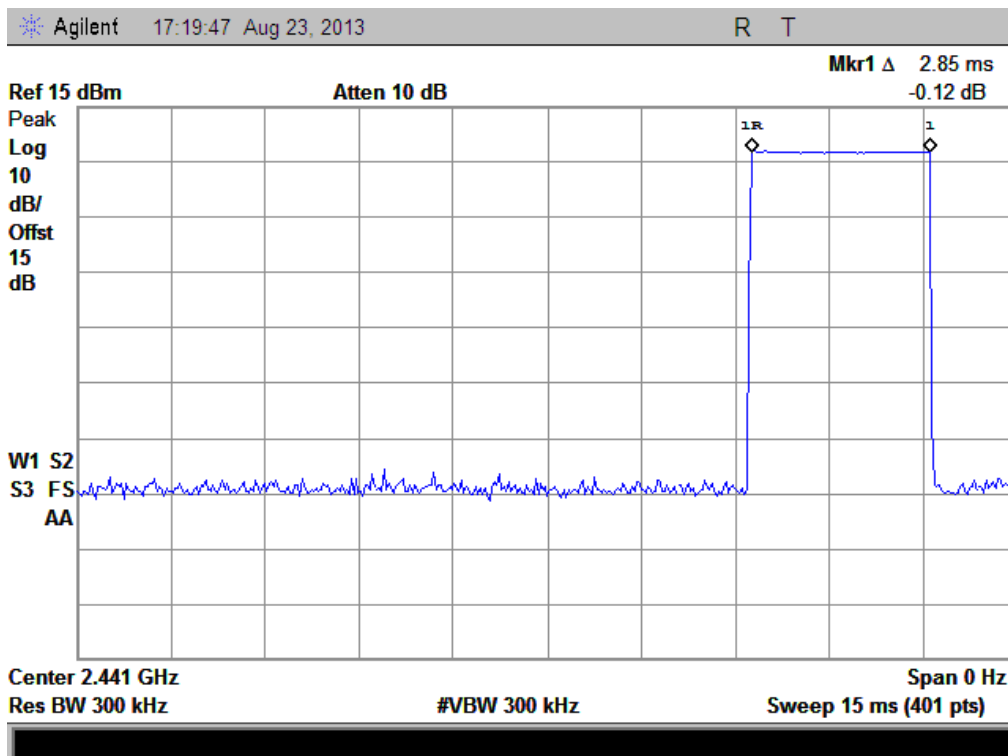


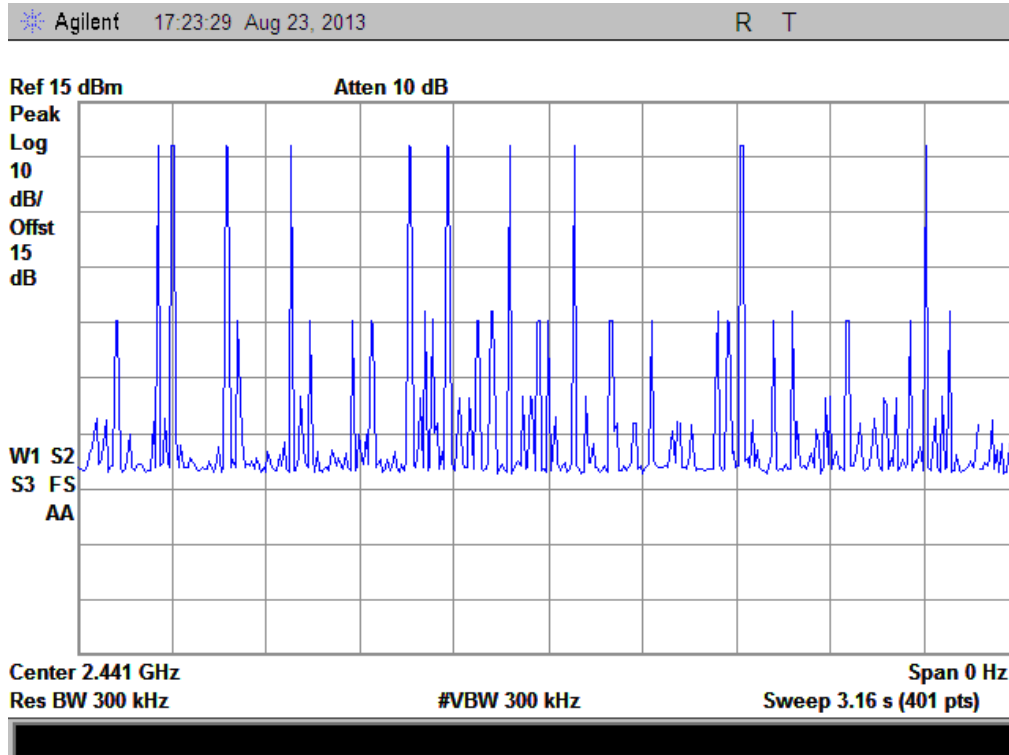
(Plot A: DH1 @ GFSK)

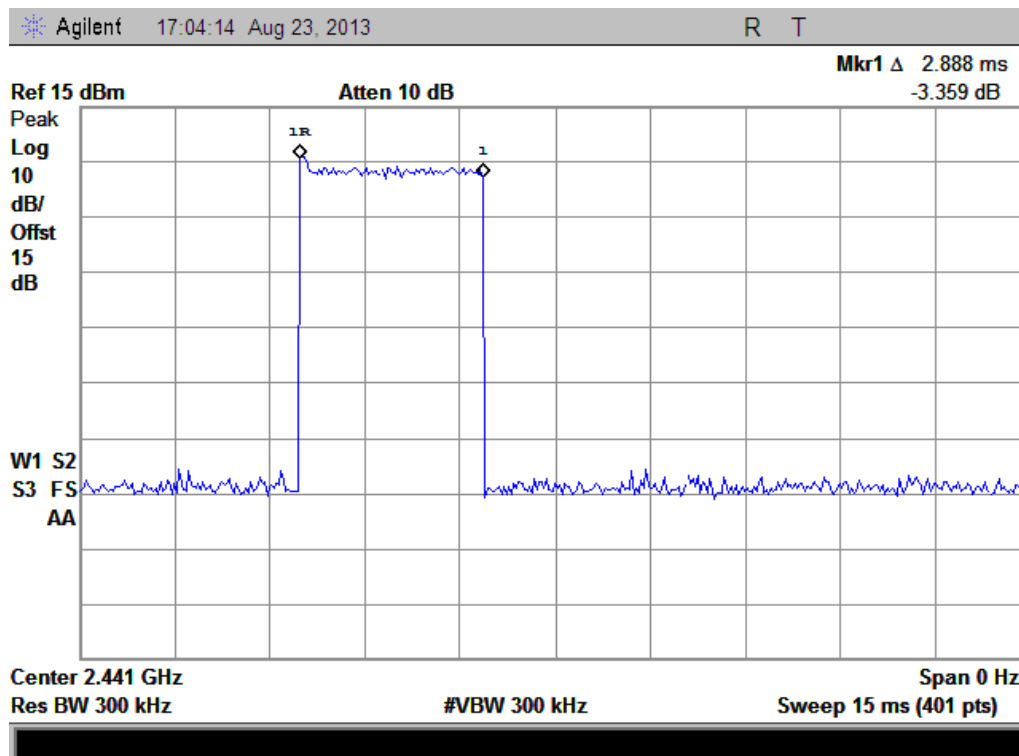


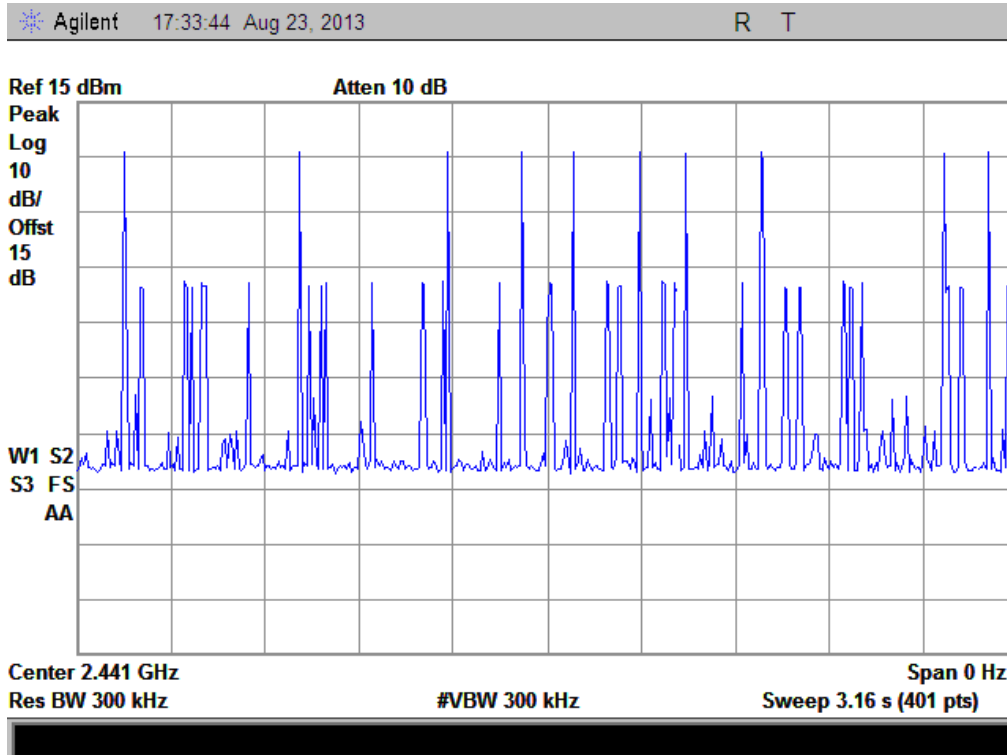
(Plot G: DH1 @ 8-DPSK)

(Plot I: DH5 @ 8-DPSK)

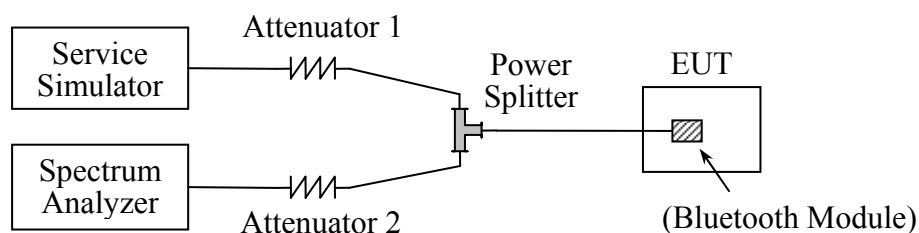
2.7. Conducted Spurious Emissions

2.7.1. Requirement

According to FCC §15.247(d), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement.

2.7.2. Test Description

A. Test Setup:



The Bluetooth Module of the EUT, which is powered by the Battery, is coupled to the Spectrum Analyzer (SA) and the Bluetooth Service Simulator (SS) with Attenuators through the Power Splitter; the RF load attached to the EUT antenna terminal is 50Ohm; the path loss as the factor is calibrated to correct the reading. 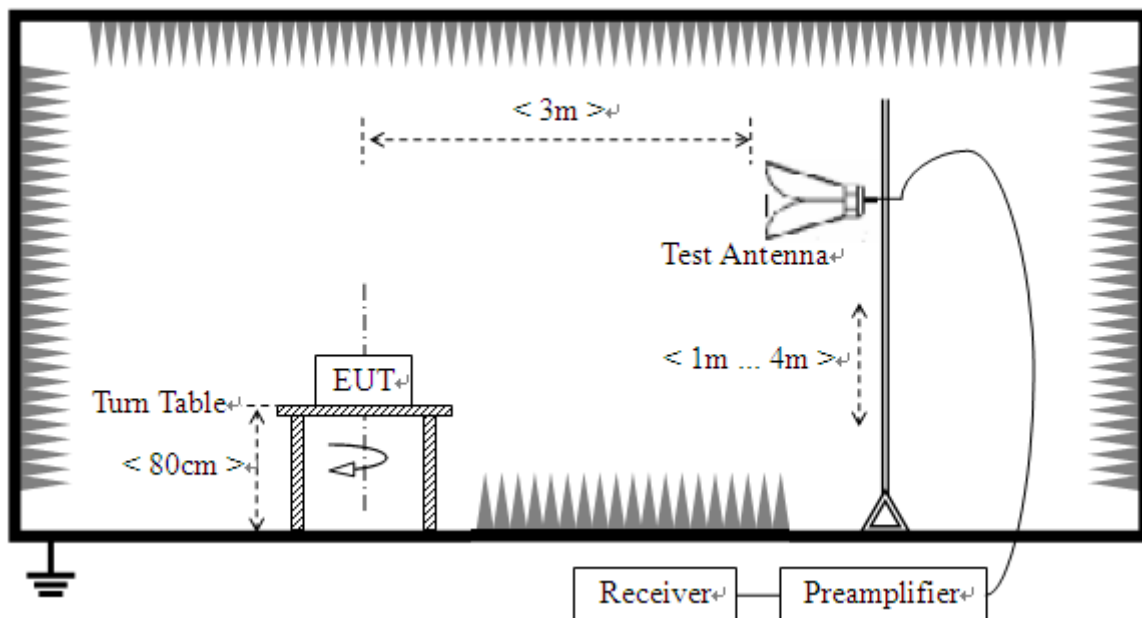
2.8. Restricted Frequency Bands

2.8.1. Requirement

According to FCC section 15.247(d), in any 100kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, In addition, radiated emissions which fall in the restricted bands, as defined in 15.205(a), must also comply with the radiated emission limits specified in 15.209(a).

For the Test Antenna:

2.9. Conducted Emission

2.9.1. Requirement

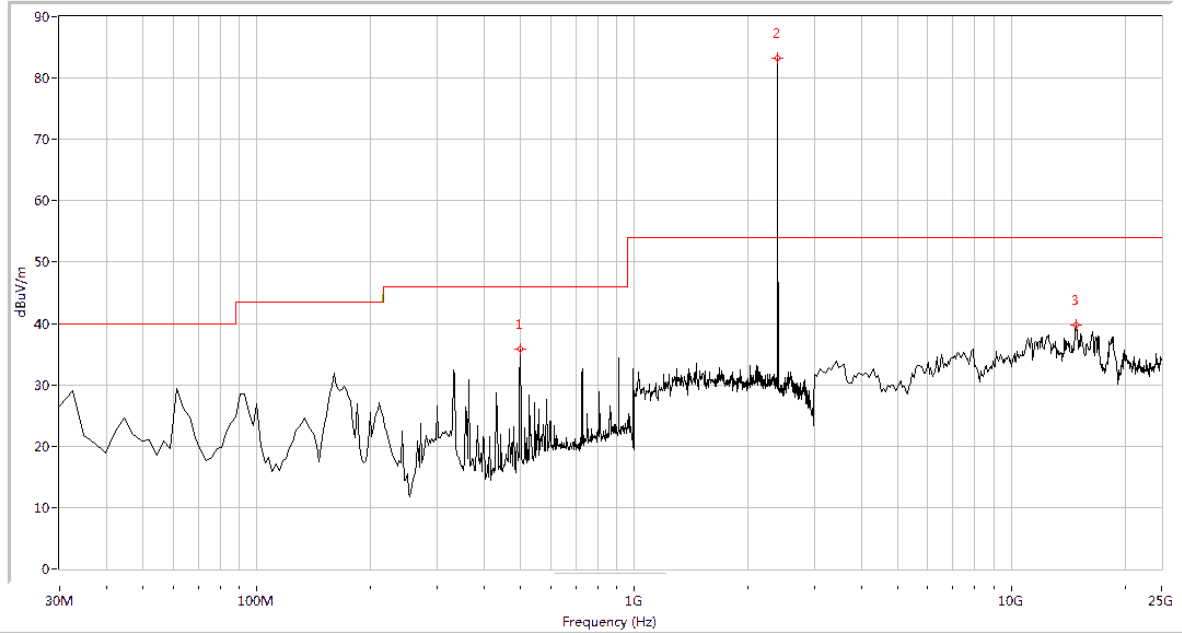


(Plot A.0: 9kHz to 30MHz @8-DPSK, channel 0)

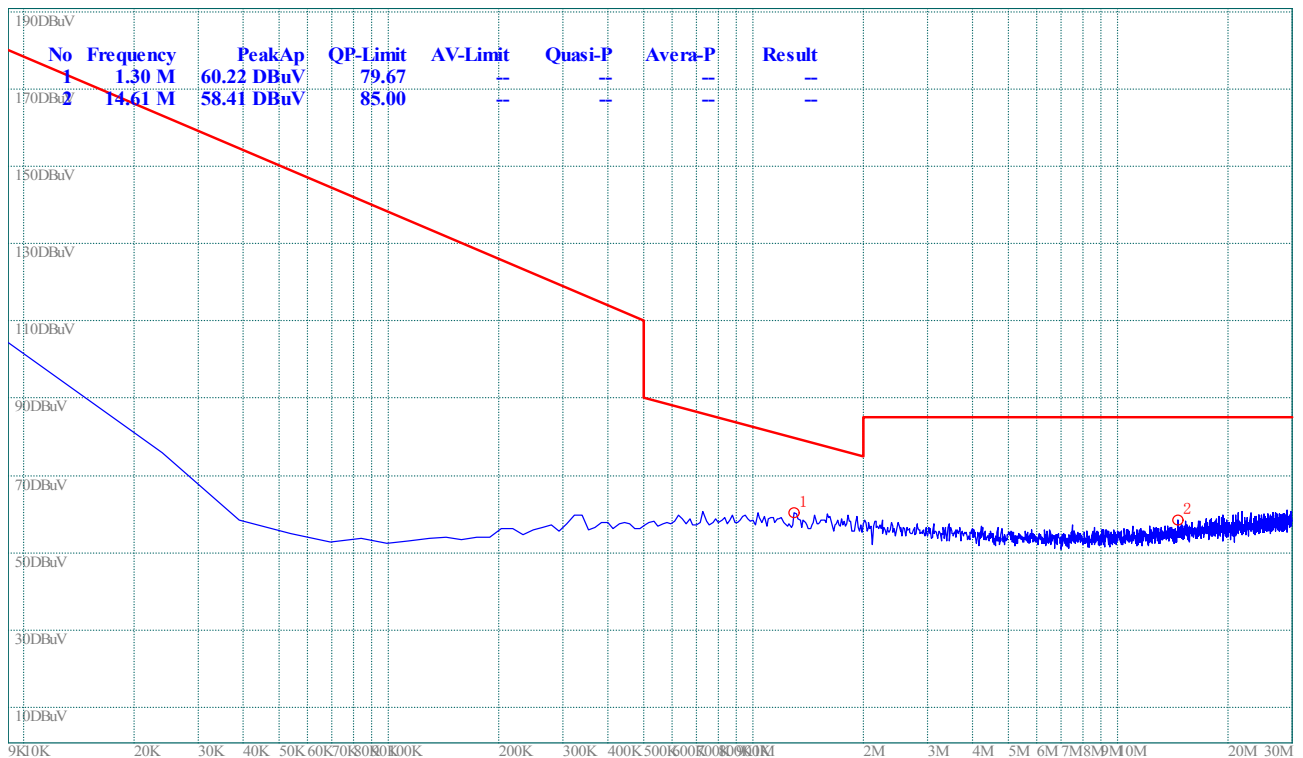
(Plot A.1: 30MHz to 25GHz, Antenna Horizontal @8-DPSK, channel 0)



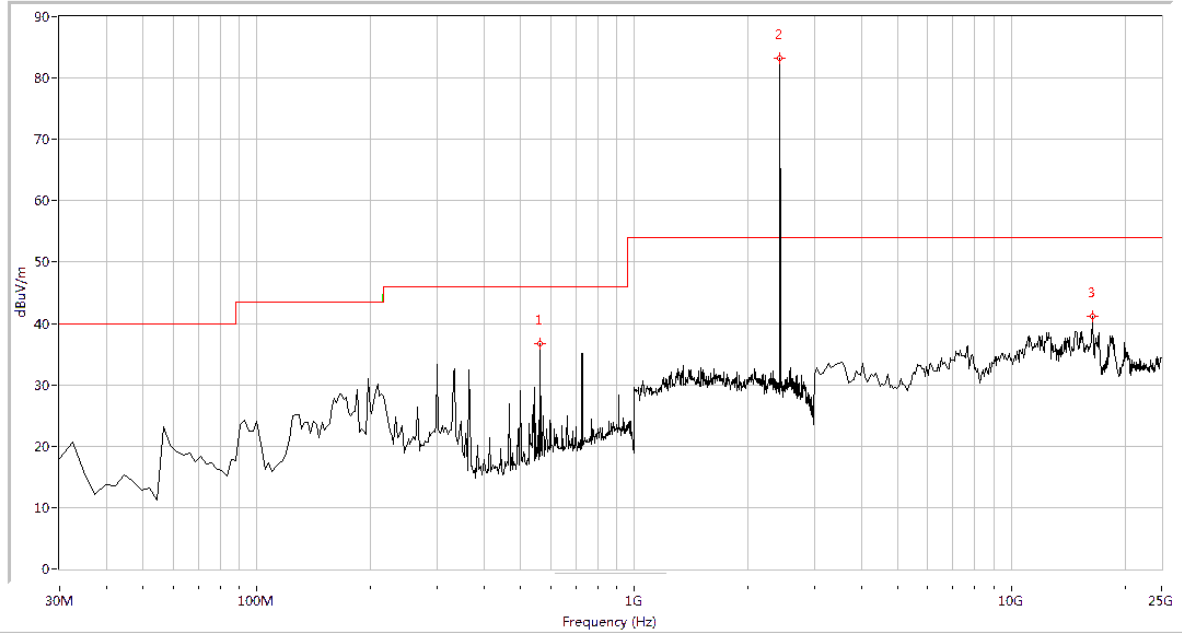

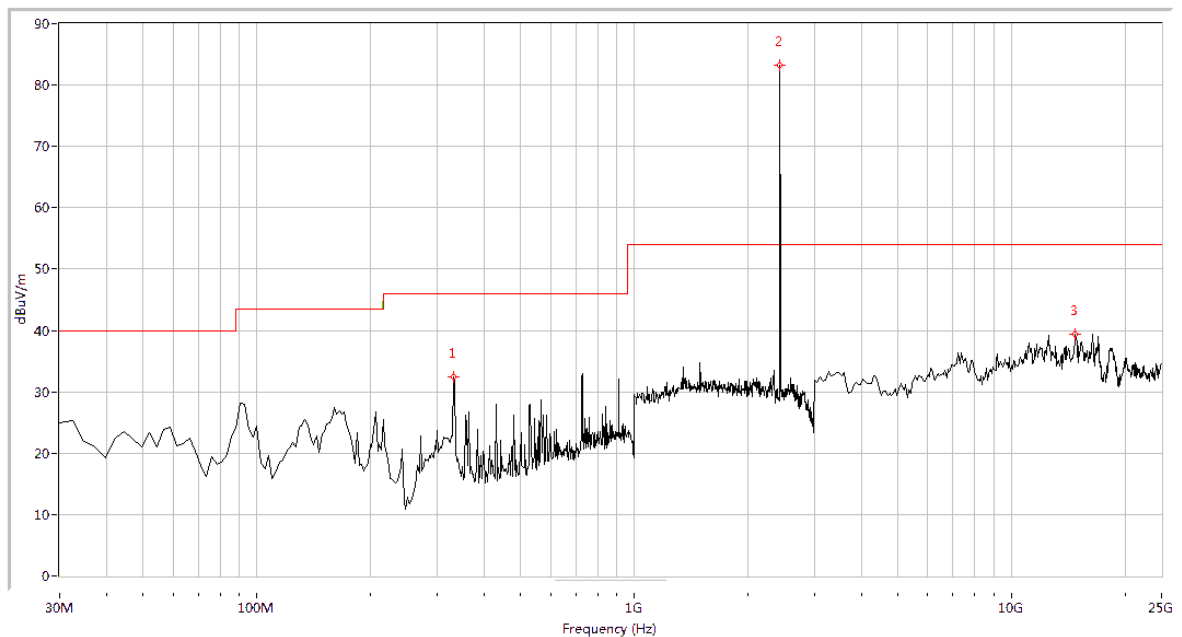


(Plot B.0: 9kHz to 30MHz @ 8-DPSK, channel 39)

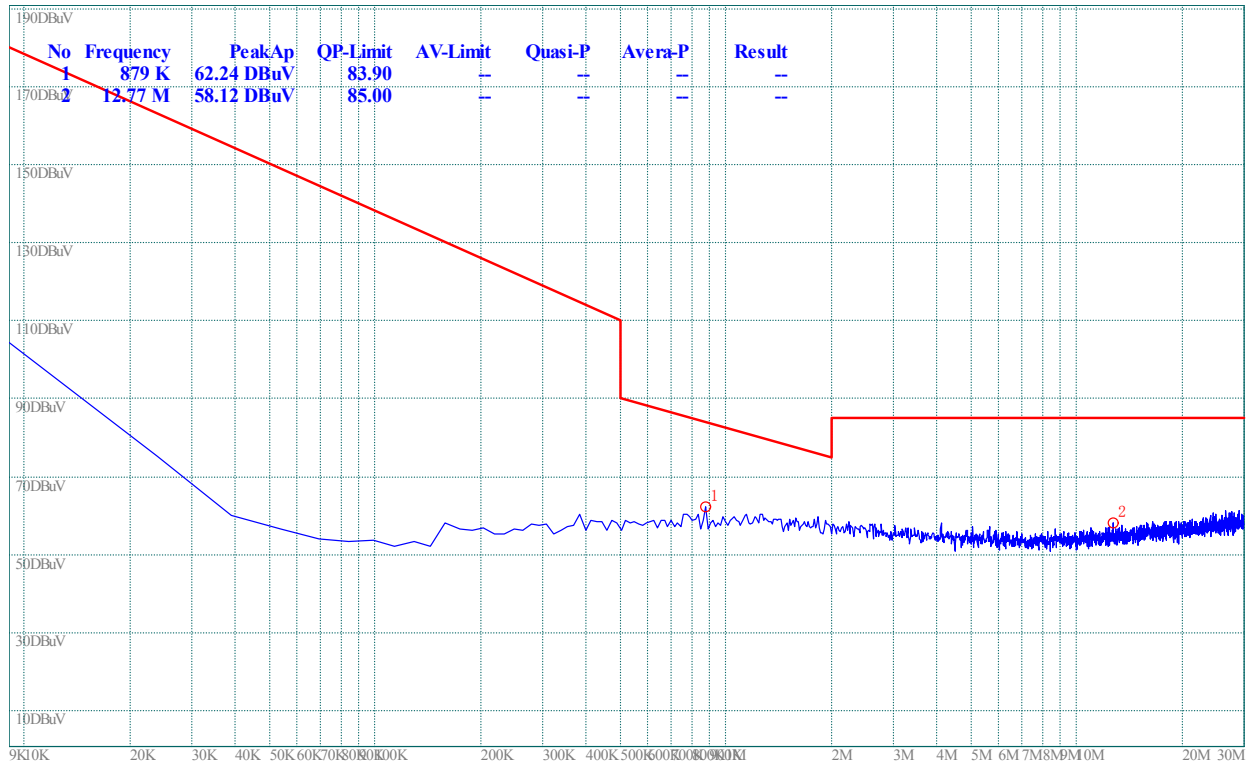
(Plot B.1: 30MHz to 25GHz, Antenna Horizontal @ 8-DPSK, channel 39)



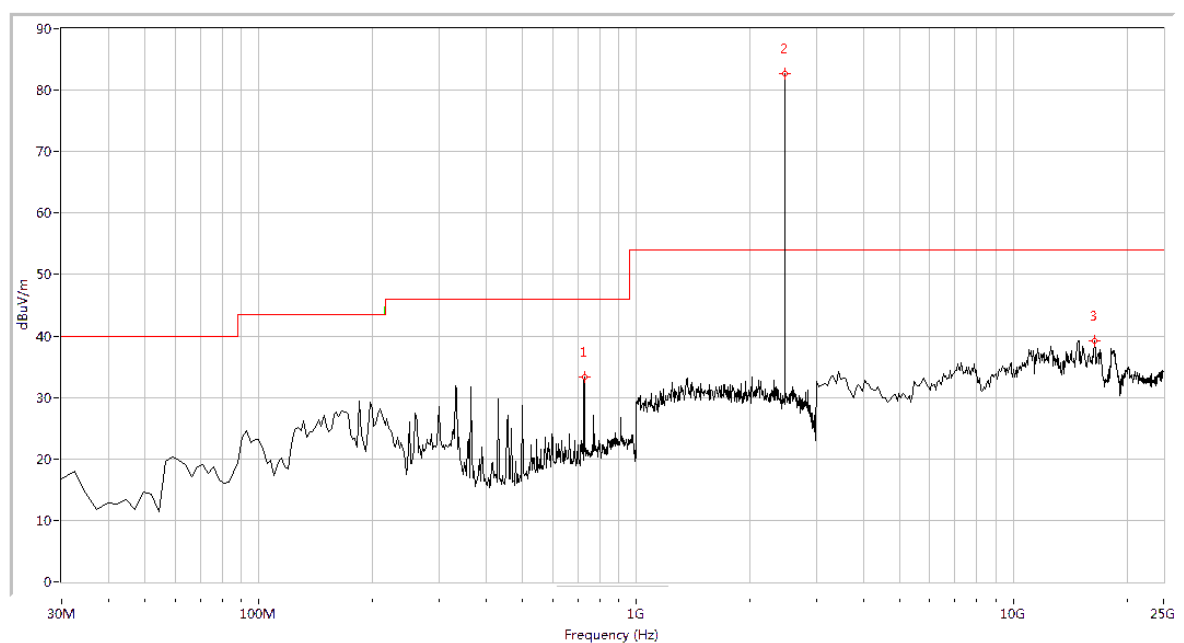

(Plot B.2: 30MHz to 25GHz, Antenna Vertical @ 8-DPSK, channel 39)

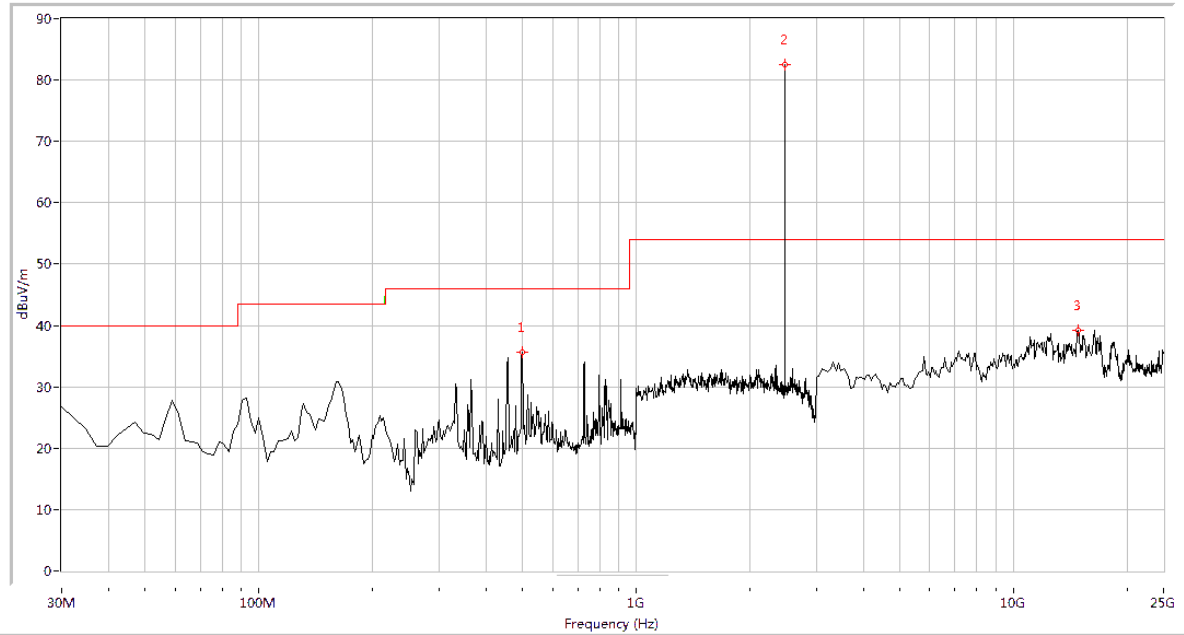
