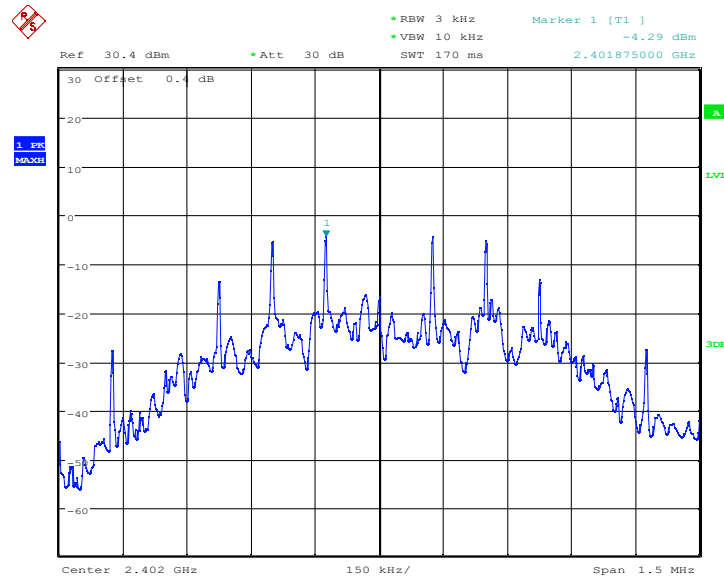

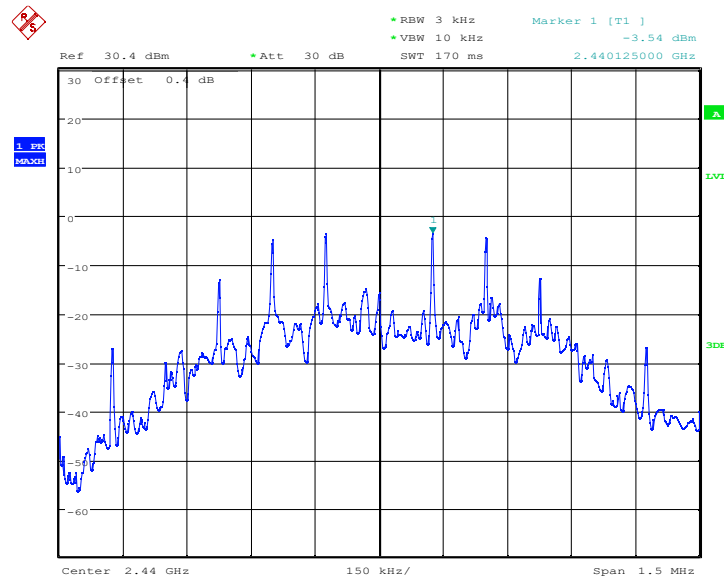

Fig.1 Power spectral density: 1M CH0 PSD/3KHz

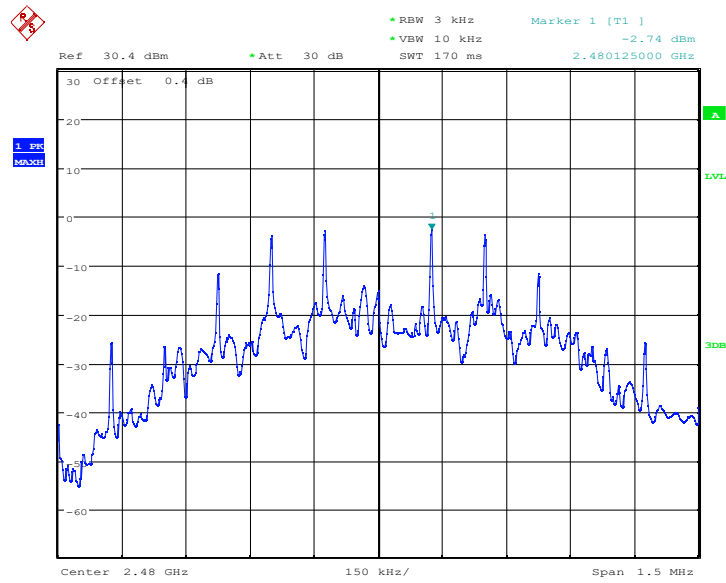

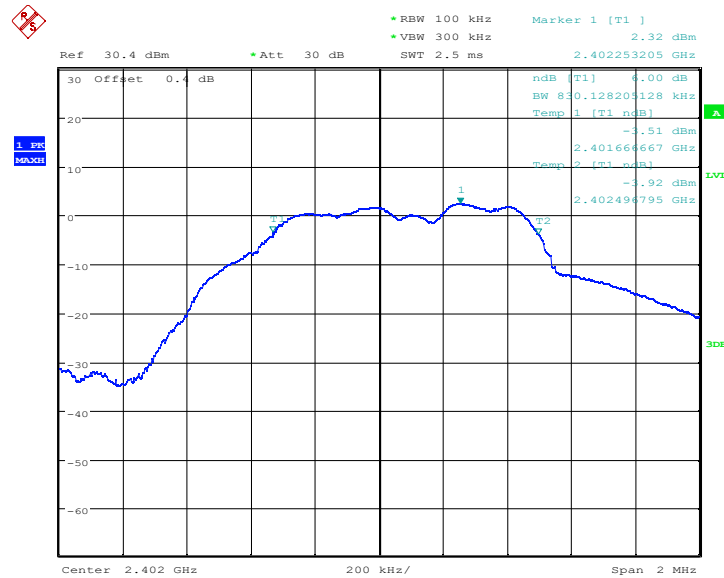

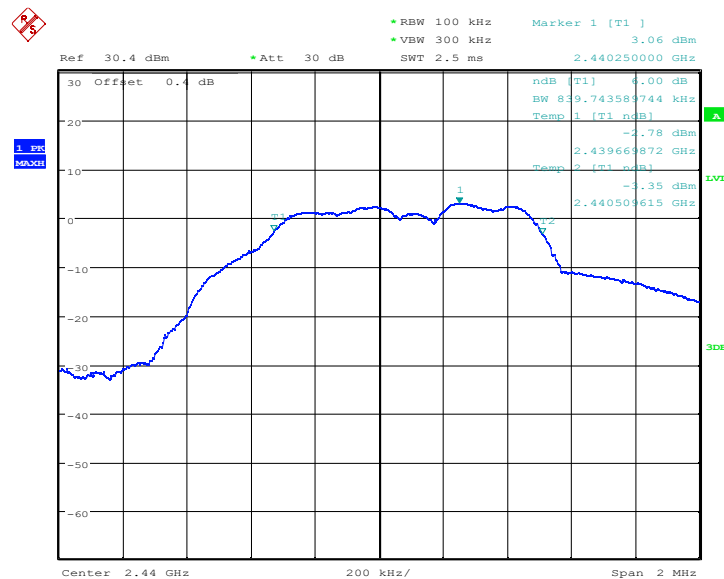

Fig.4 6dB Bandwidth: 1M Ch0

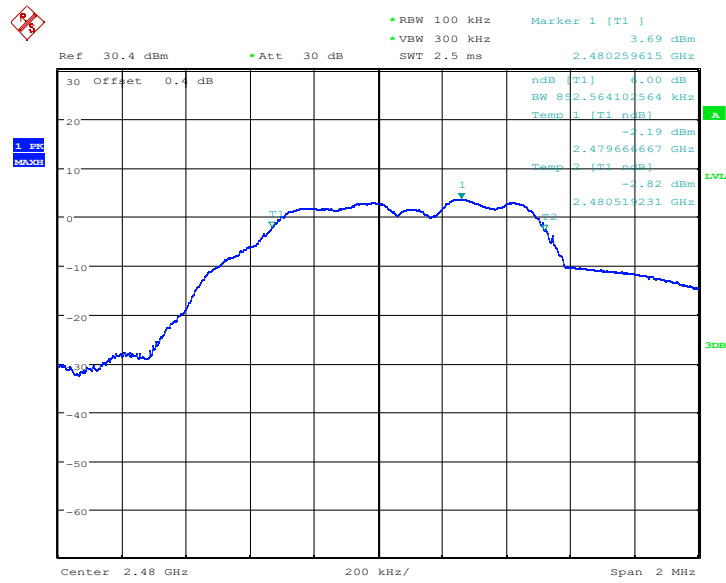

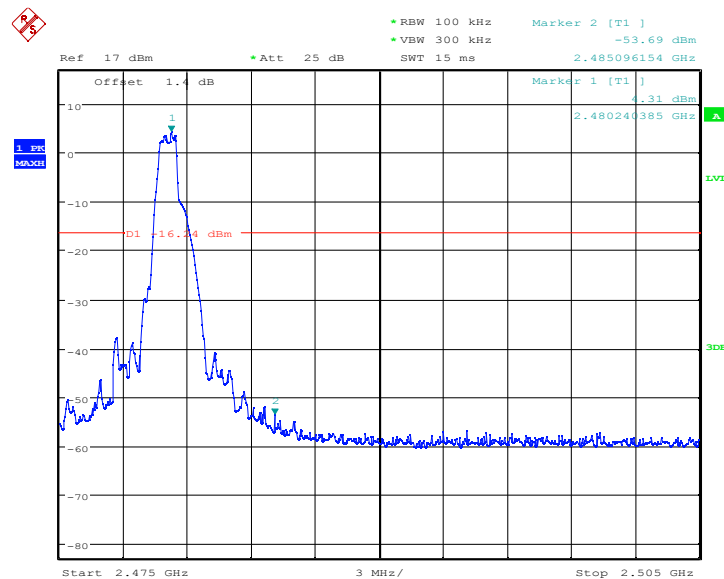

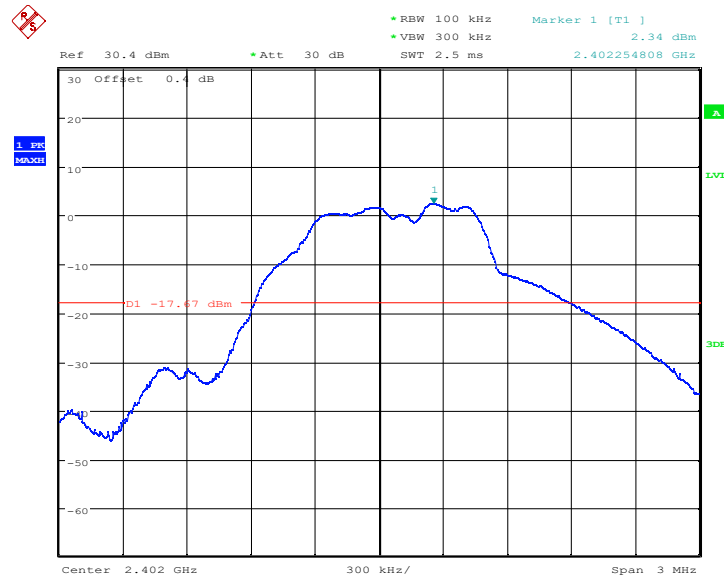

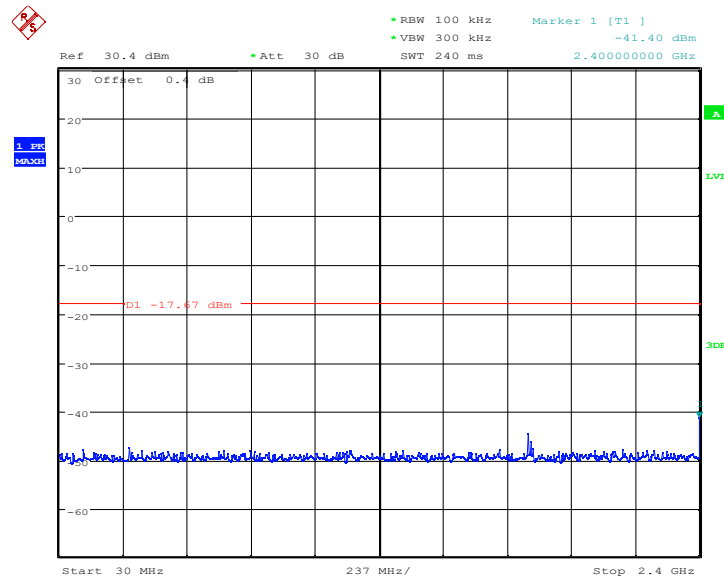

Fig.9 Conducted spurious emission: 1M Ch0

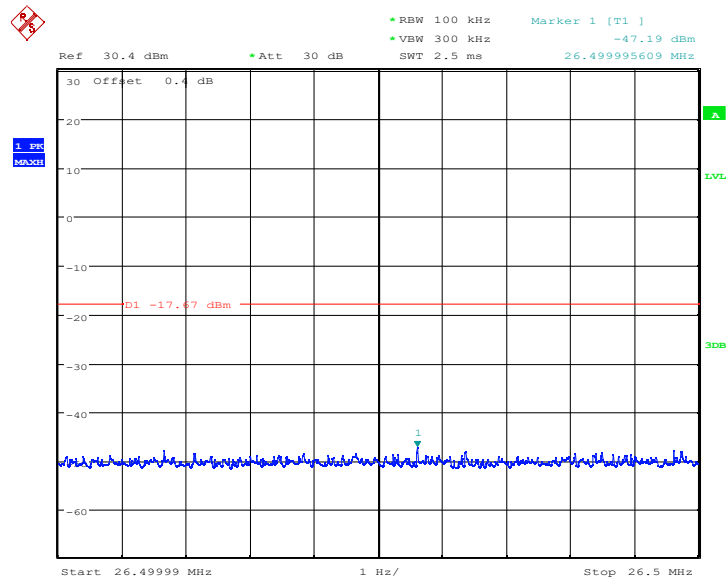

Fig.10 Conducted spurious emission: 1M Ch0, 30MHz~2.4GHz

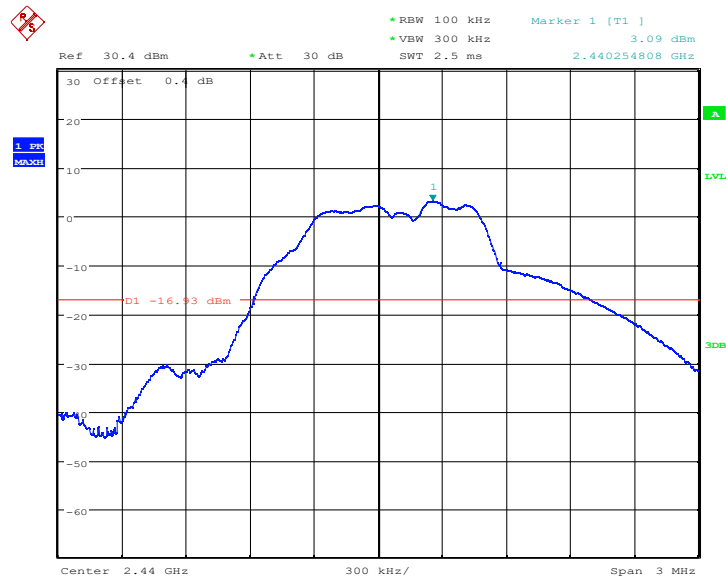

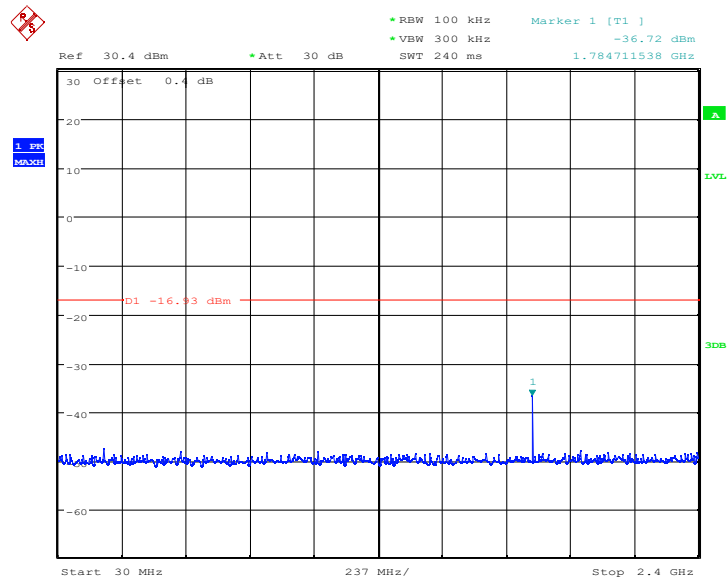

Fig.11 Conducted spurious emission: 1M Ch0, 2.4835GHz~26.5GHz



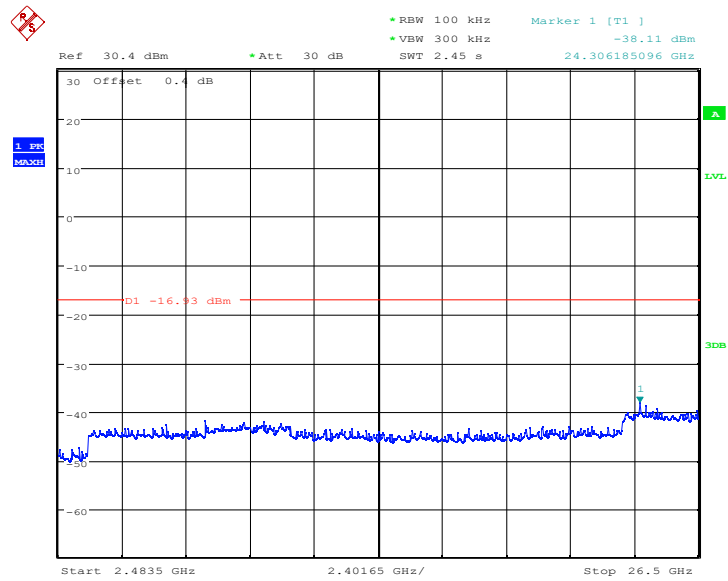

Fig.12 Conducted spurious emission: 1M Ch19



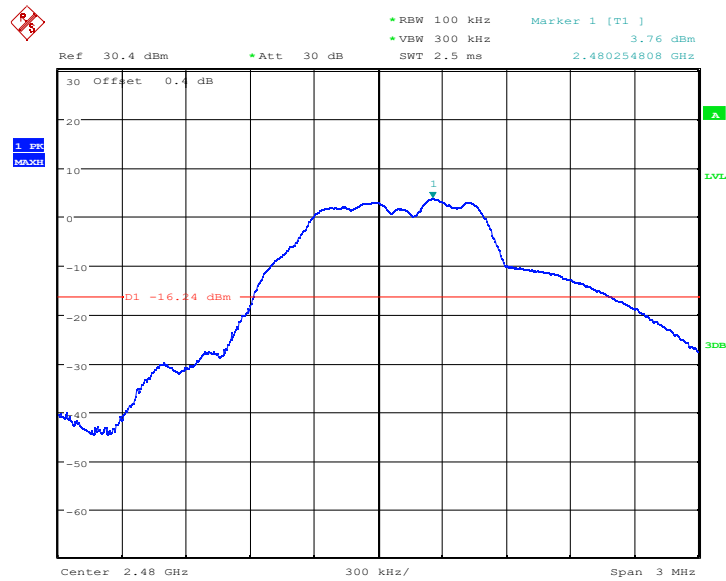

Fig.13 Conducted spurious emission: 1M Ch19, 30MHz~2.4GHz



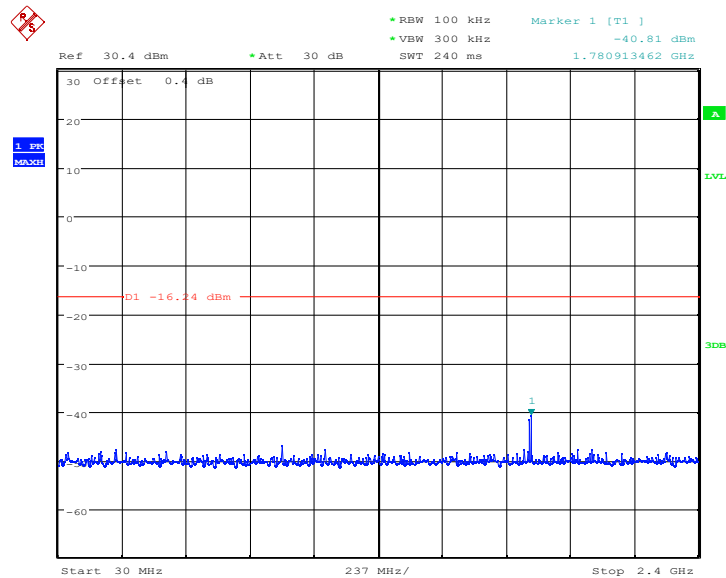

Fig.15 Conducted spurious emission: 1M Ch39

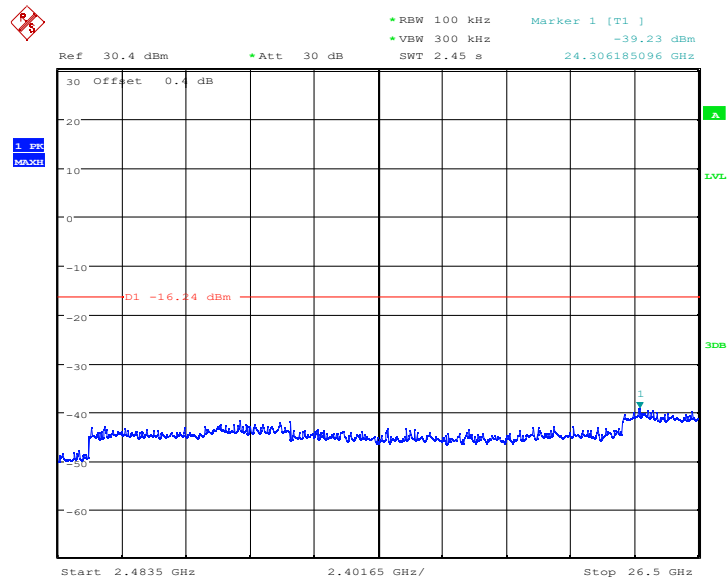

Test Procedure

Portable, small, lightweight, or modular devices that may be handheld, worn on the body, or placed on a table during operation shall be positioned on a non-conducting platform, the top of which is 80 cm above the reference ground plane. The preferred area occupied by the EUT arrangement is 1 m by 1.5 m, but it may be larger or smaller to accommodate various sized EUTs. For testing purposes, ceiling- and wall-mounted devices also shall be positioned on a tabletop (see also ANSI C63.10-2013 section 6.3.4 and 6.3.5). 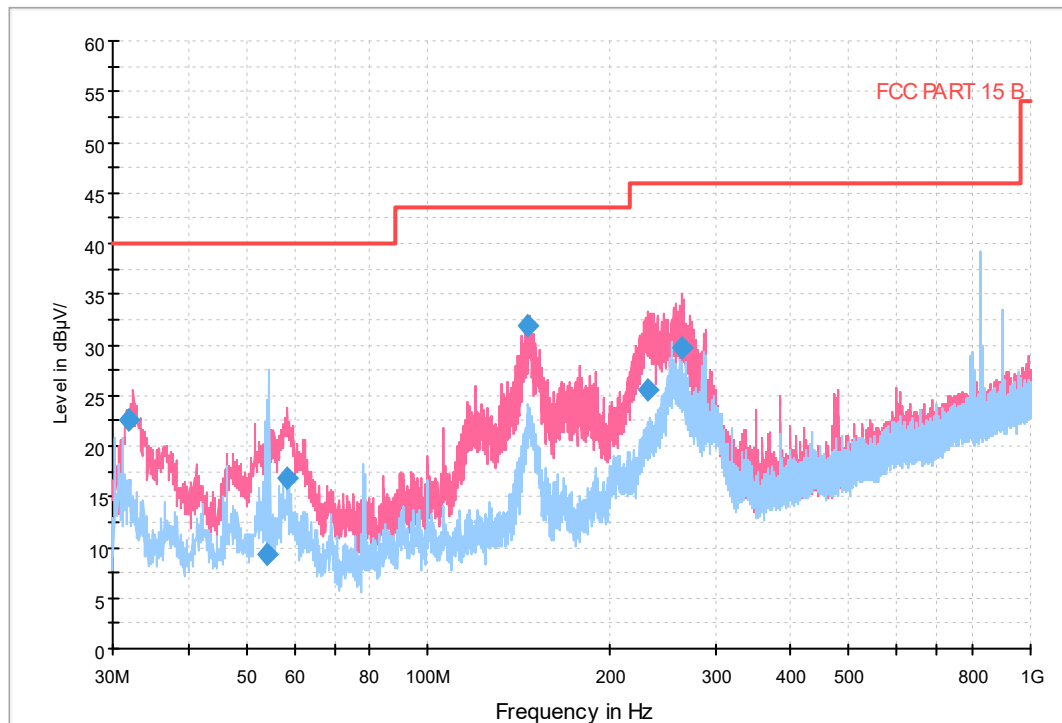


Fig.18 Radiated emission: Ch19, 1M, 30MHz-1GHz

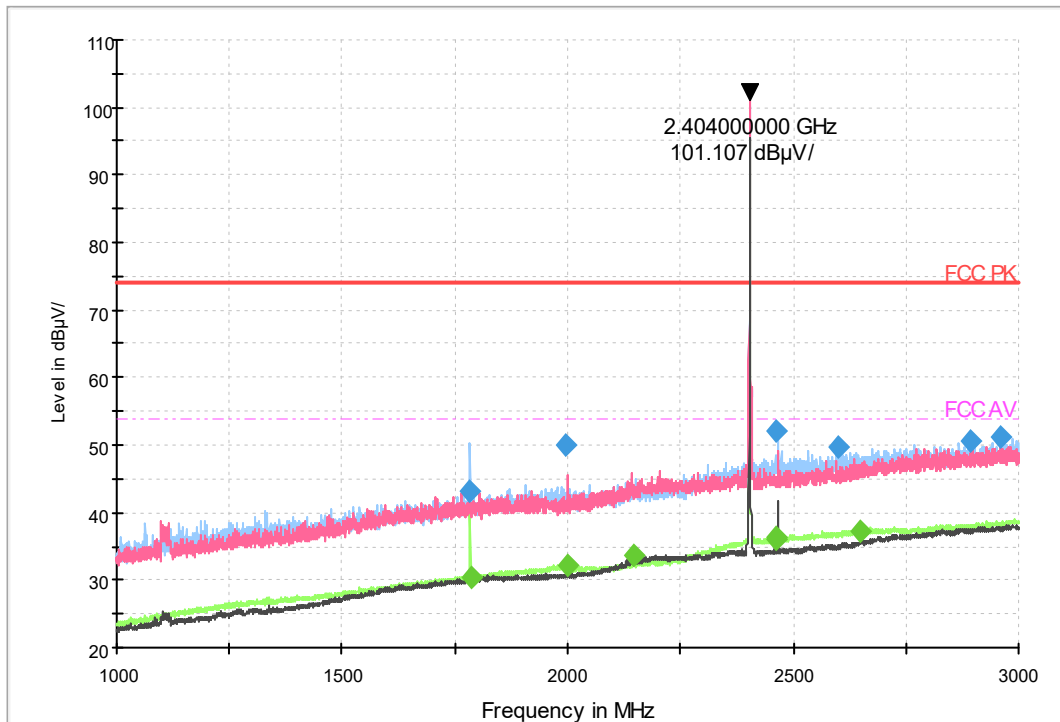


Fig.19 Radiated emission: Ch0, 1M 1GHz-3GHz

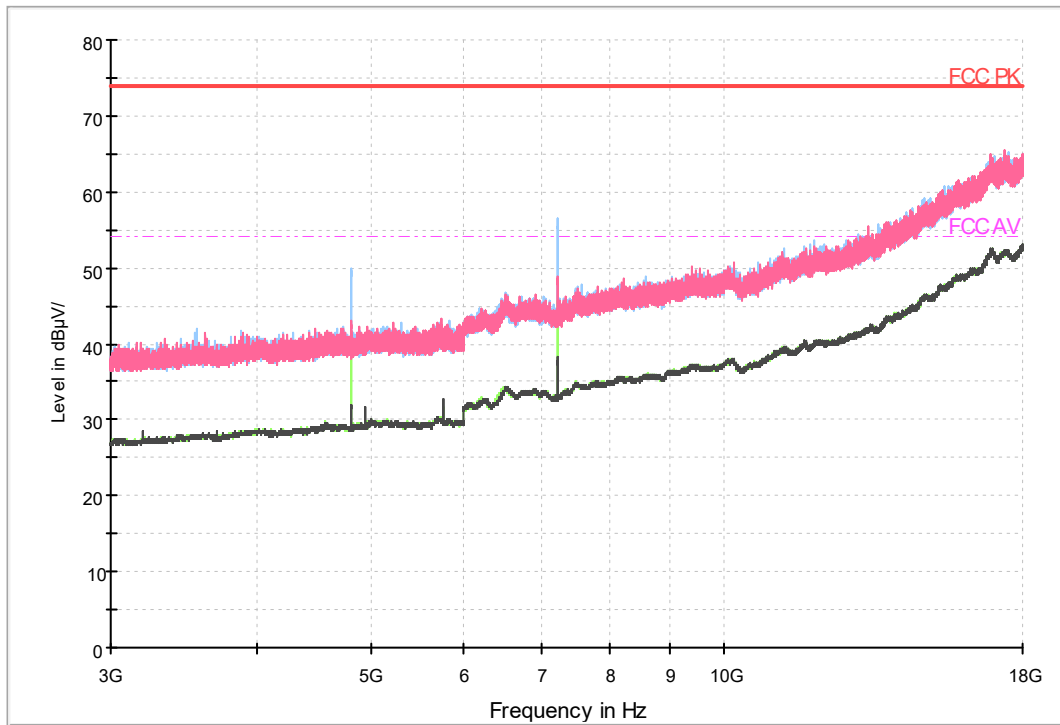


Fig.20 Radiated emission: Ch0, 1M, 3GHz-18GHz

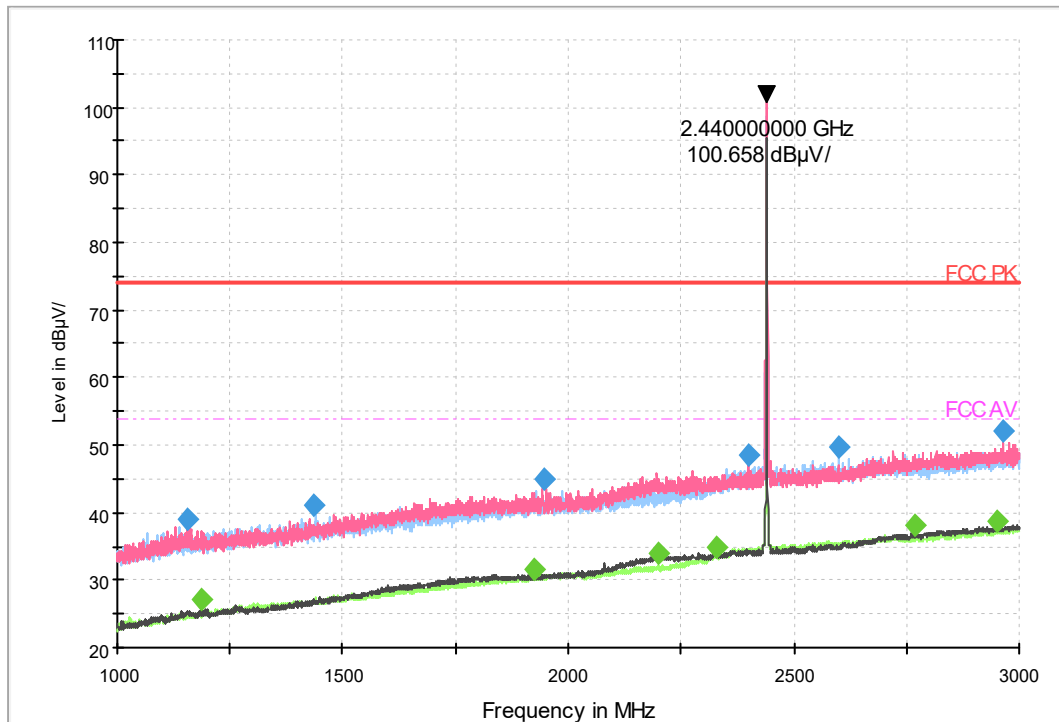


Fig.21 Radiated emission: Ch19,1M 1GHz-3GHz

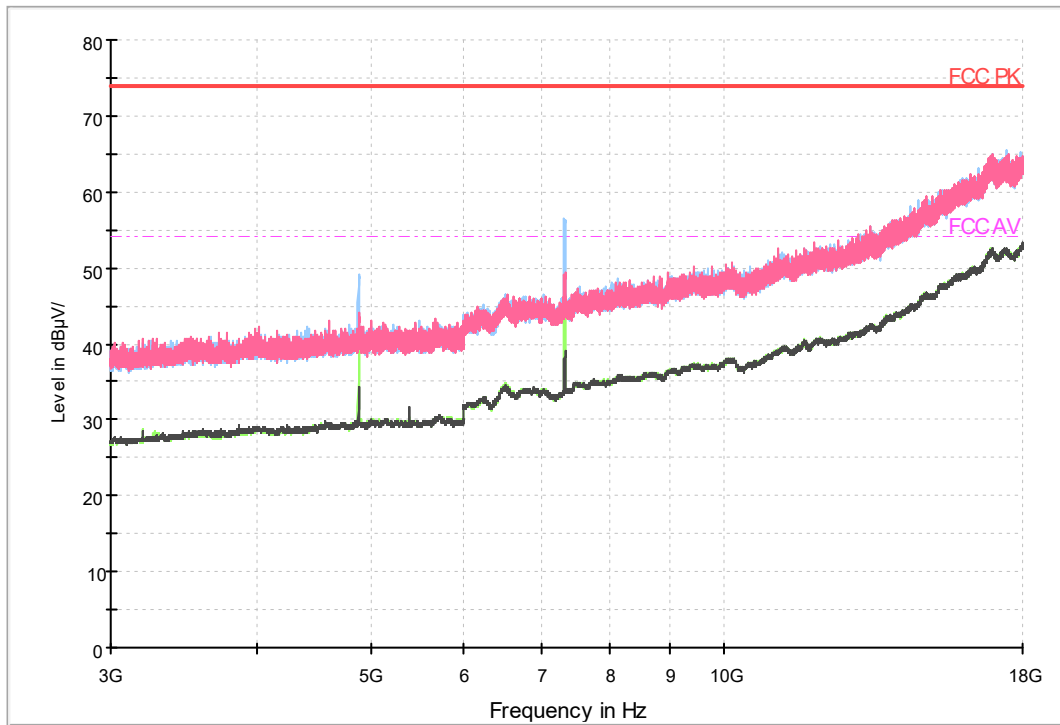


Fig.22 Radiated emission: Ch19, 1M 3GHz-18GHz

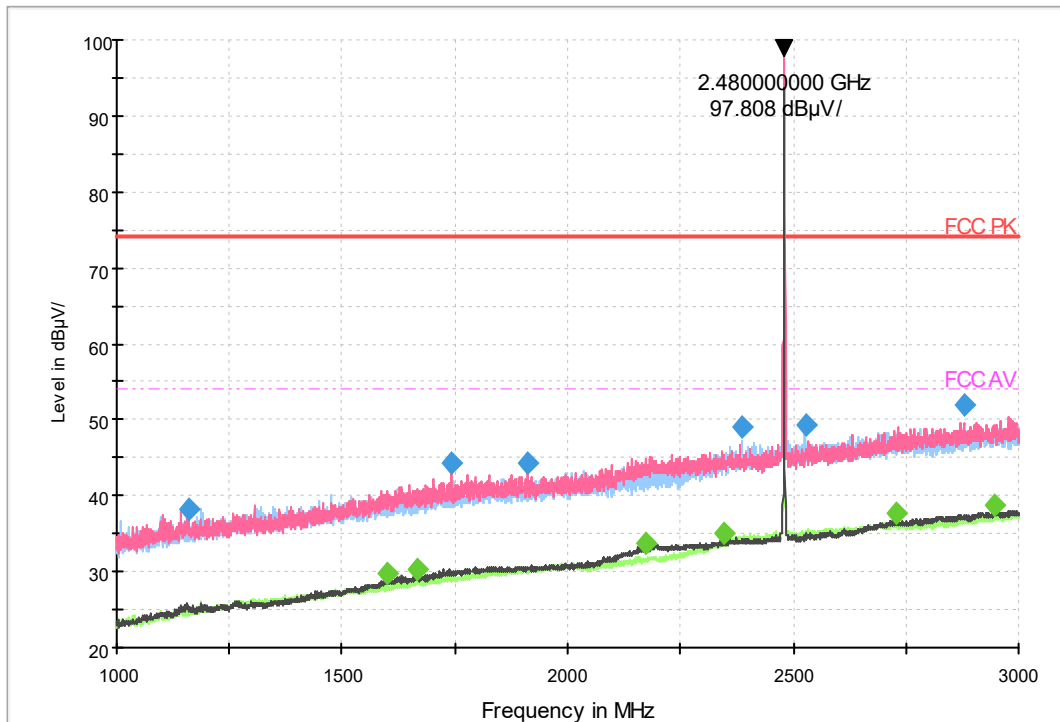


Fig.23 Radiated emission: 1M Ch39, 1GHz-3GHz

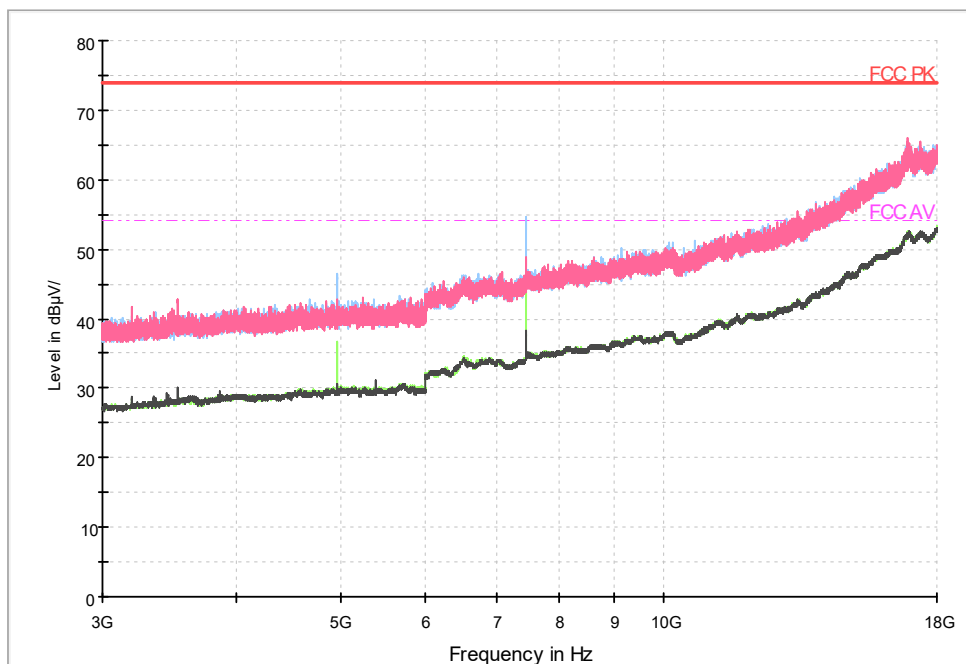


Fig.24 Radiated emission: Ch39, 1M 3GHz-18GHz

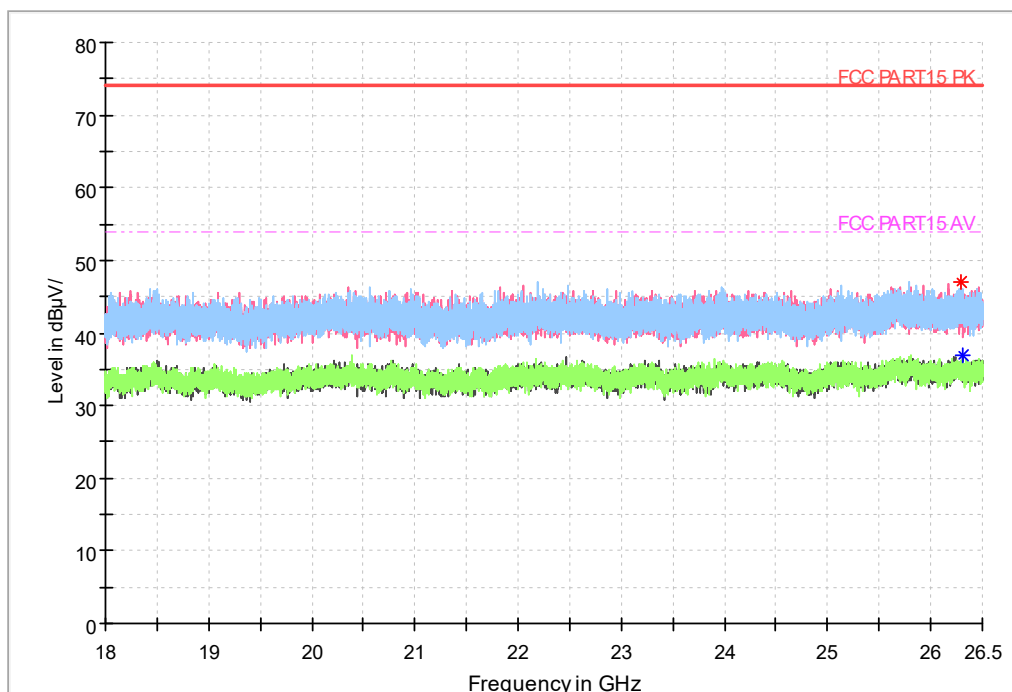


Fig.25 Radiated emission: 18 GHz - 26.5 GHz

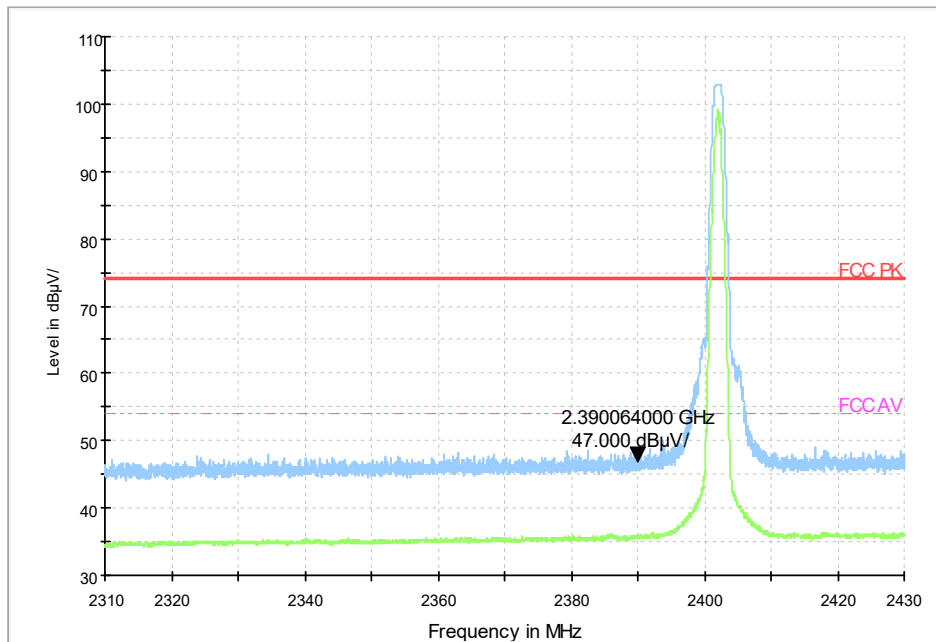


Fig.26 Frequency Band Edge:1M Ch0

BAND EDGERE 1GHz-3GHz 2.45-2.5G

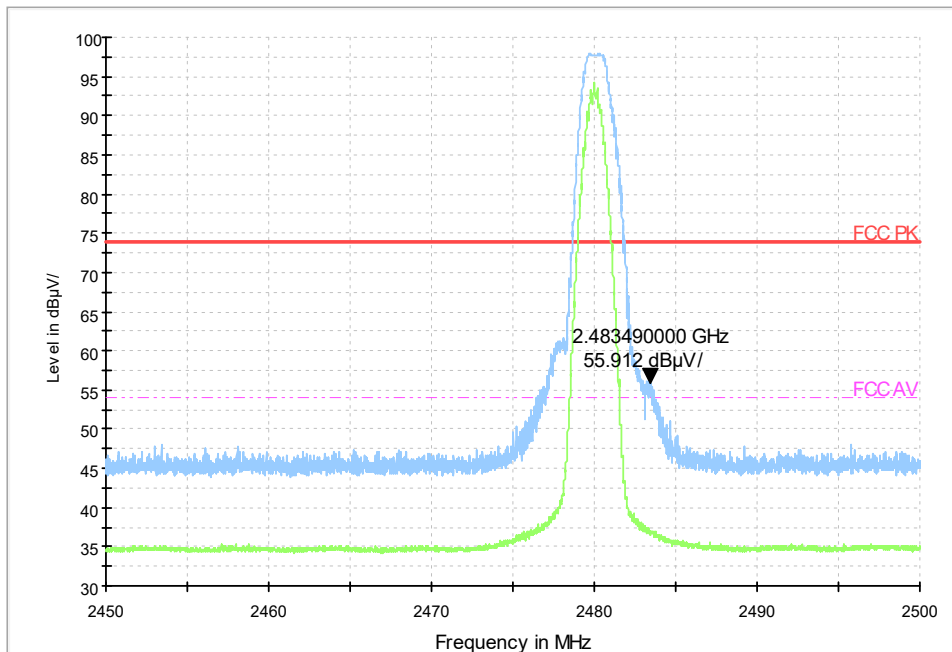


Fig.27 Frequency Band Edge: 1M Ch39

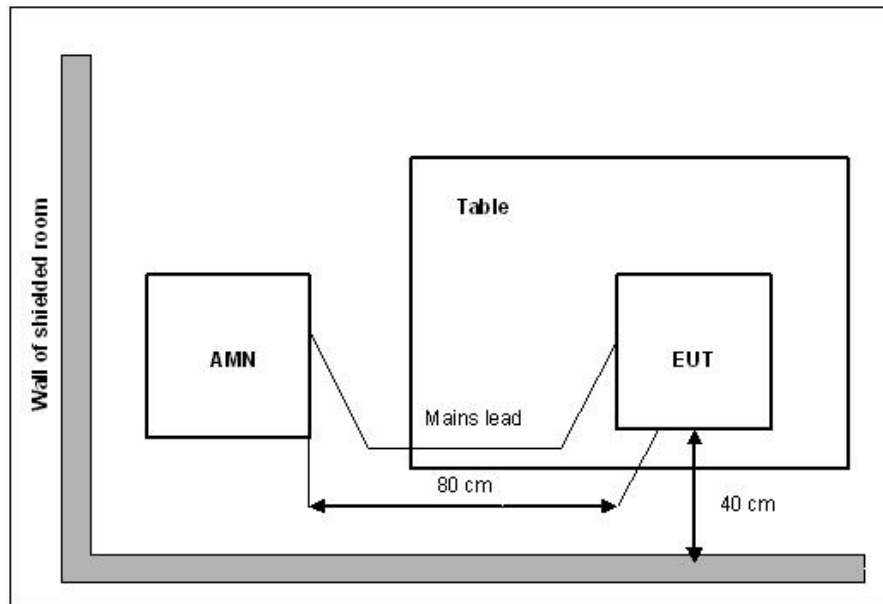

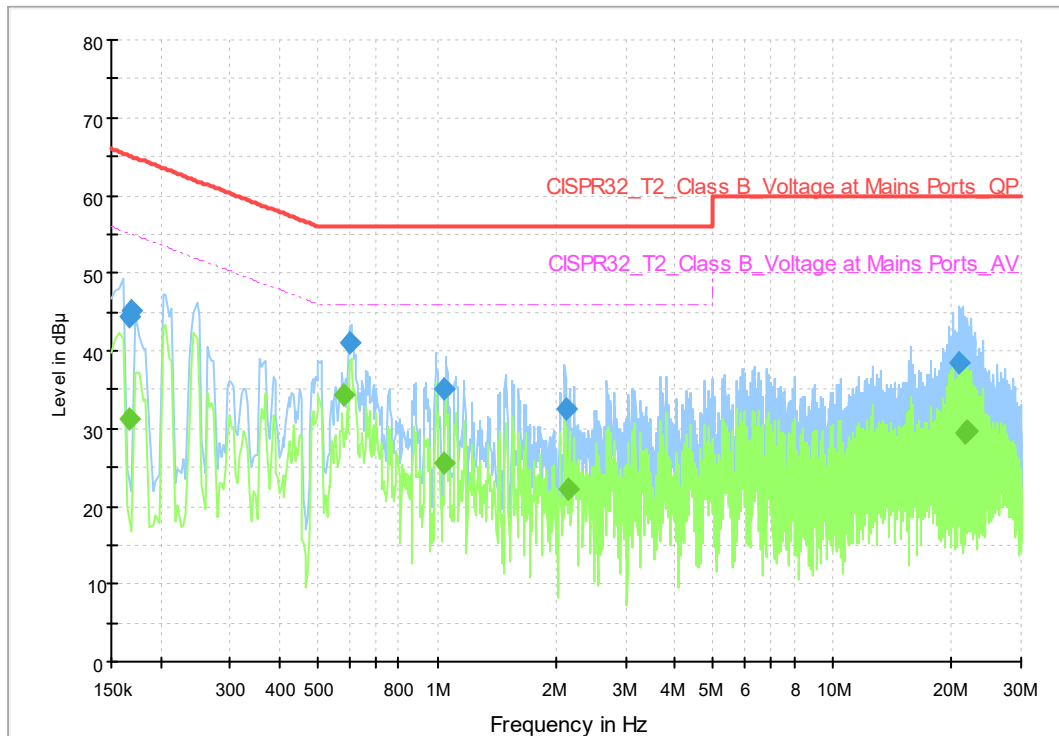
