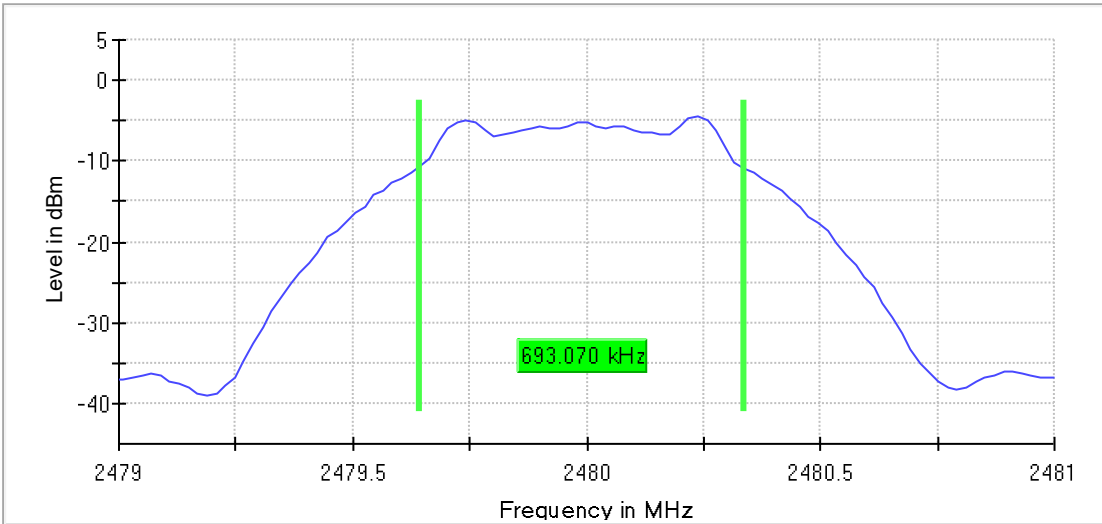

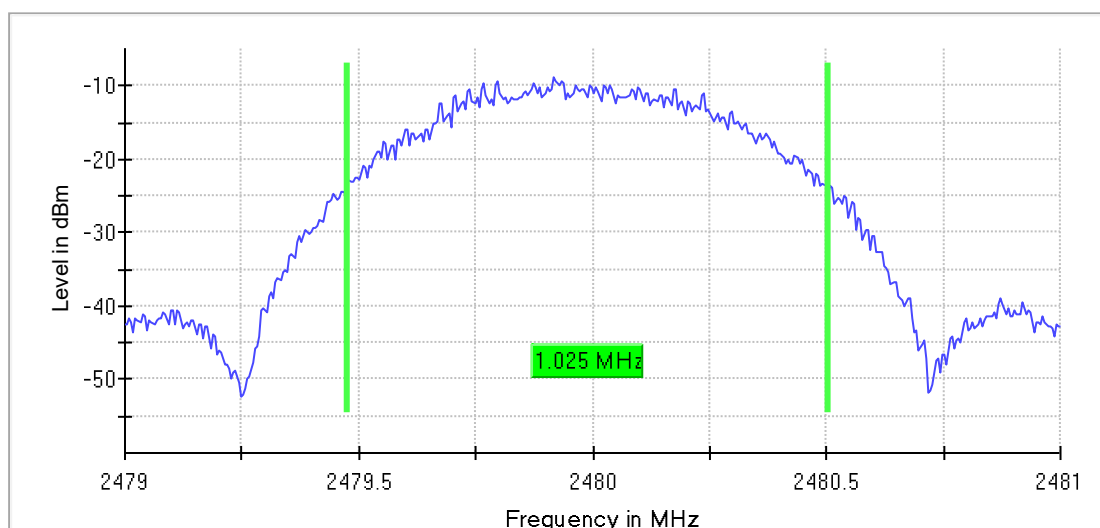

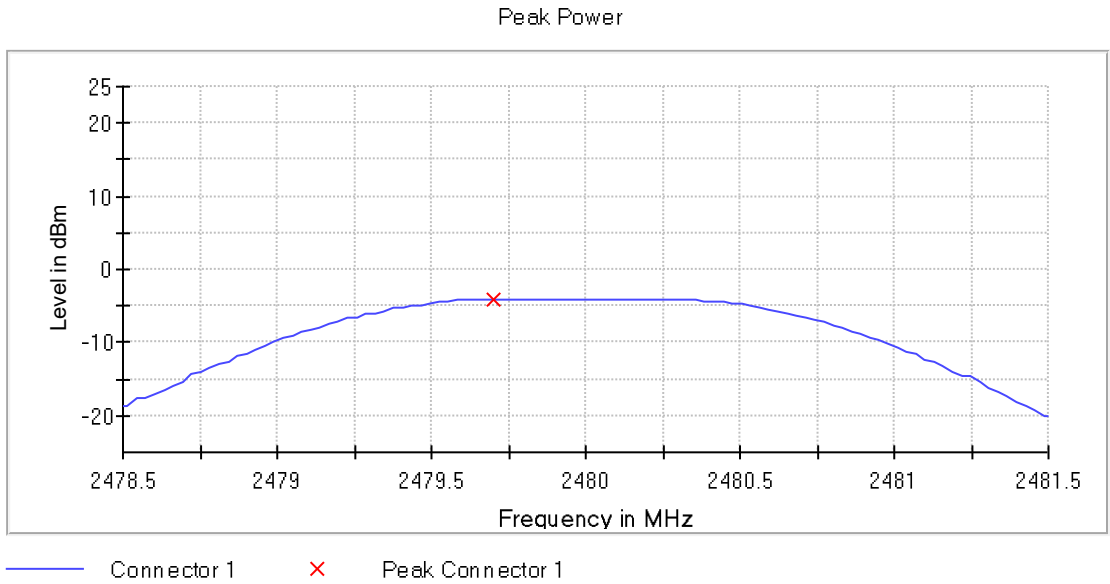
Mode 1, Channel 37



Mode 1, Channel 17



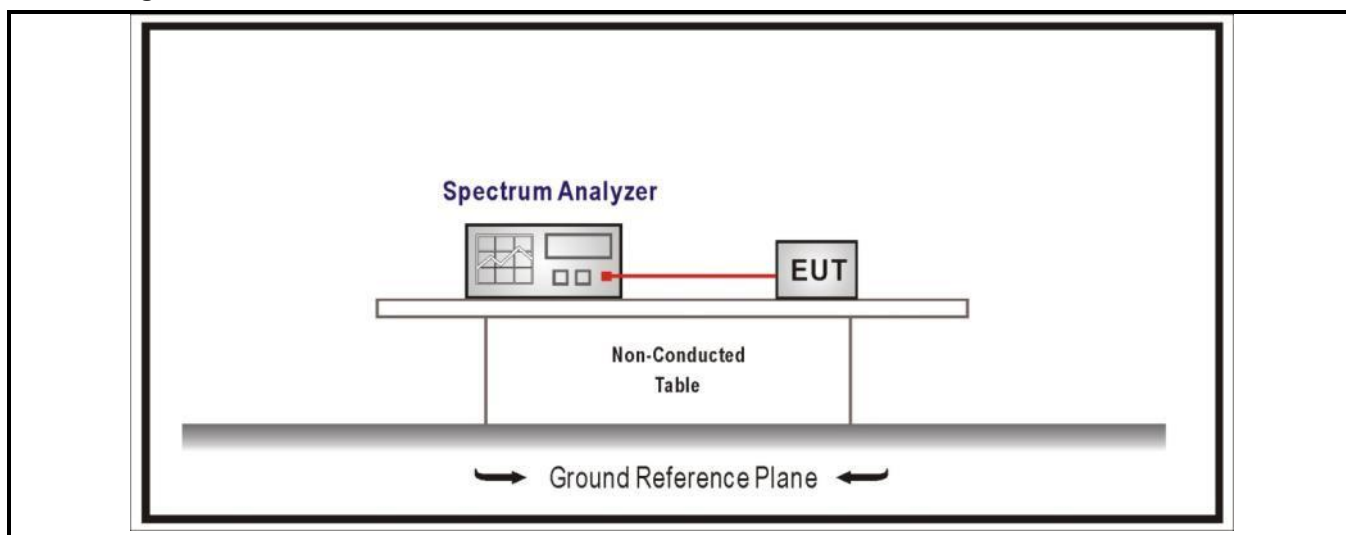

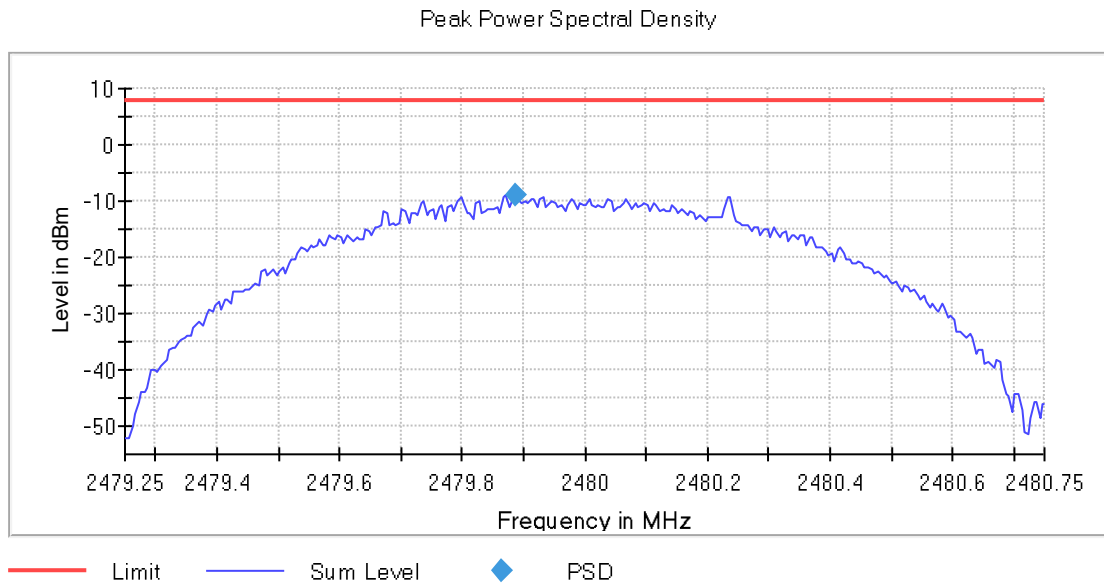
Mode 1, Channel 37
