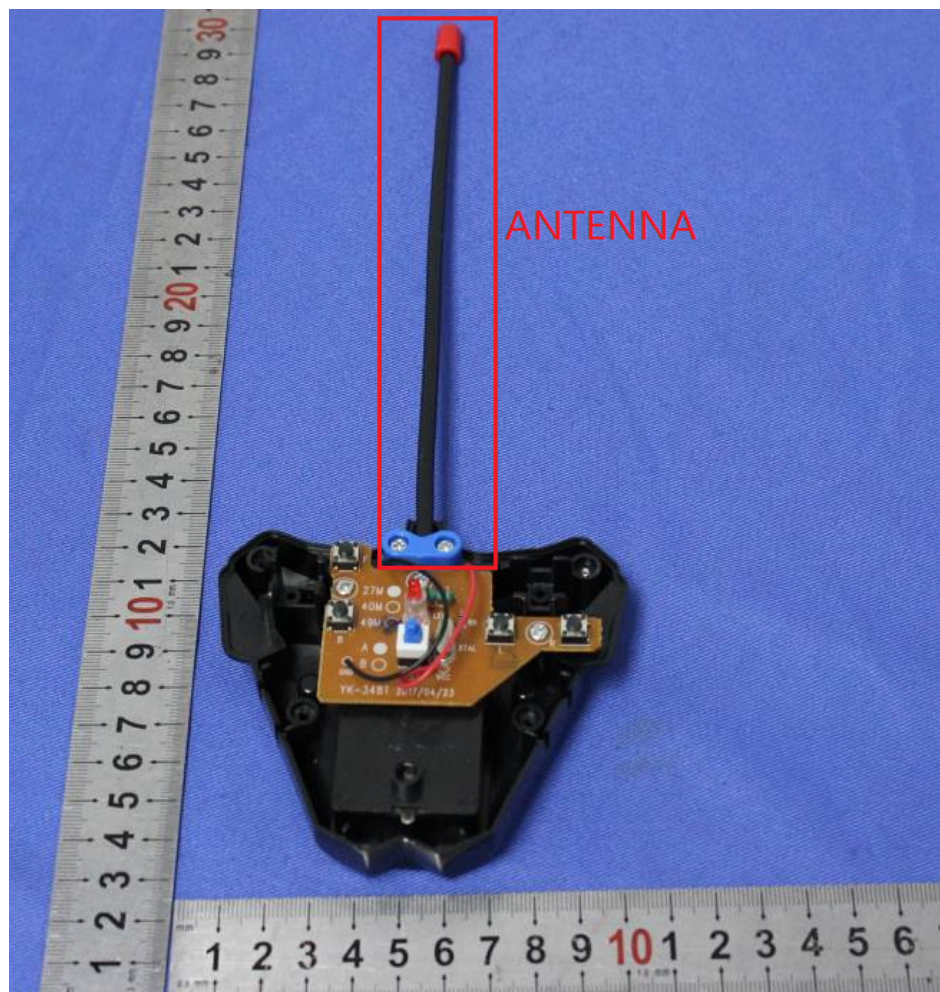
6.1.2 Conclusion

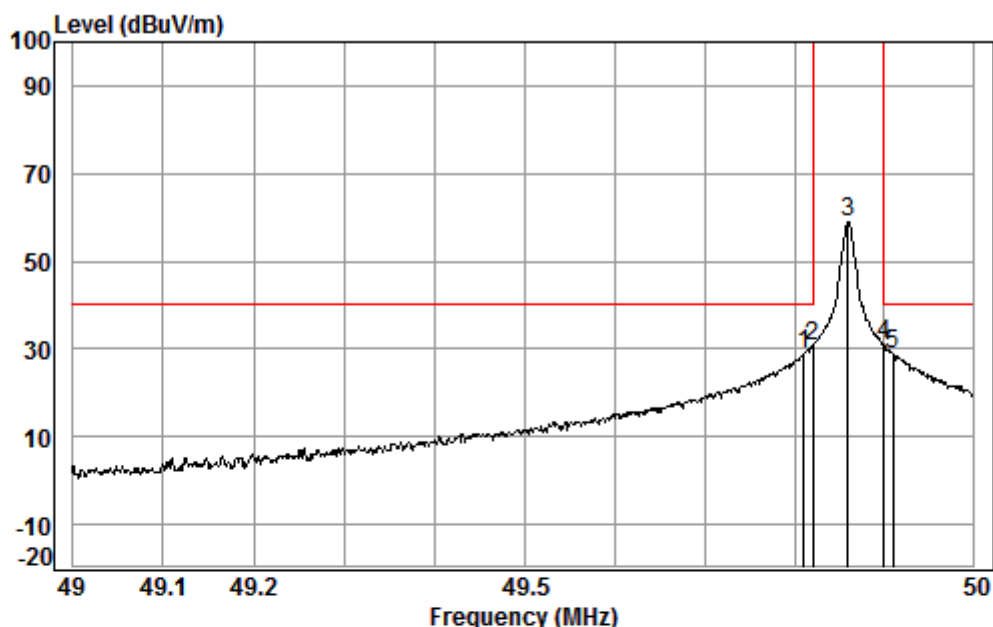

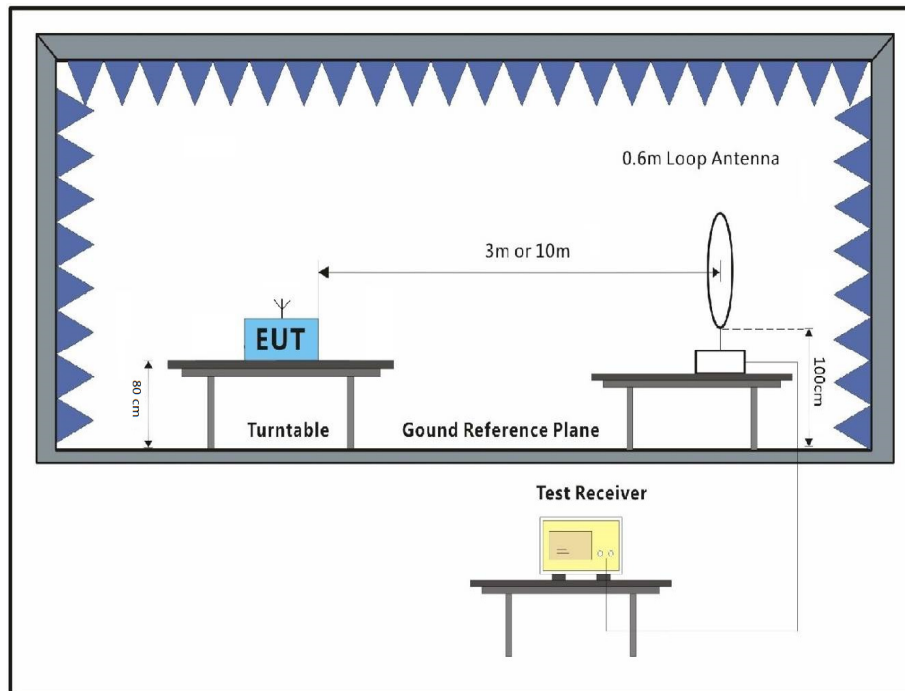

7.3.3 Measurement Procedure and Data

For testing performed with the loop antenna, the center of the loop was positioned 1 m above the ground and positioned with its plane vertical at the specified distance from the EUT. During testing the loop was rotated about its vertical axis for maximum response at each azimuth and also investigated with the loop positioned in the horizontal plane. Only the worst position of vertical was shown in the report.

Remark: Test was conducted from 9 kHz to 30MHz and the least margin will be more than 10 dB to the limit, so it is not recorded in the report.

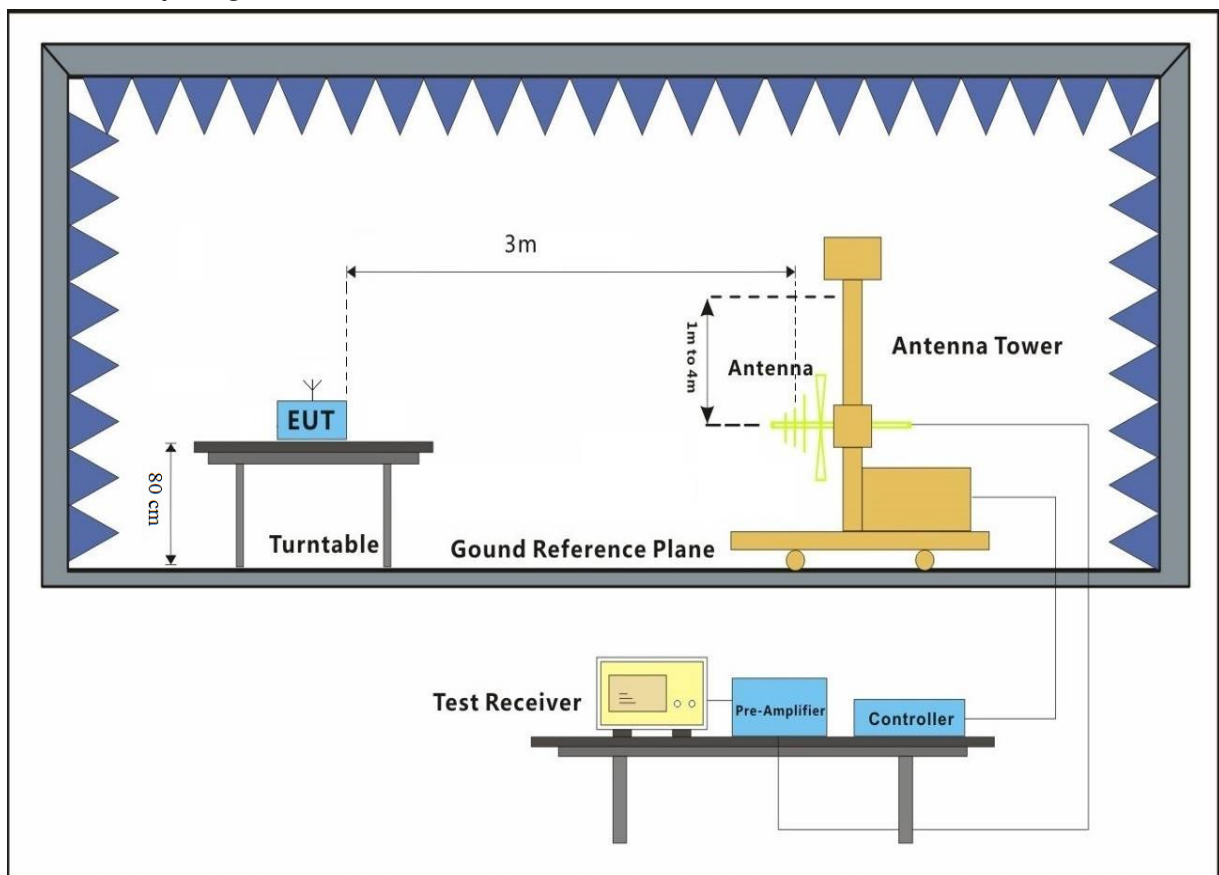

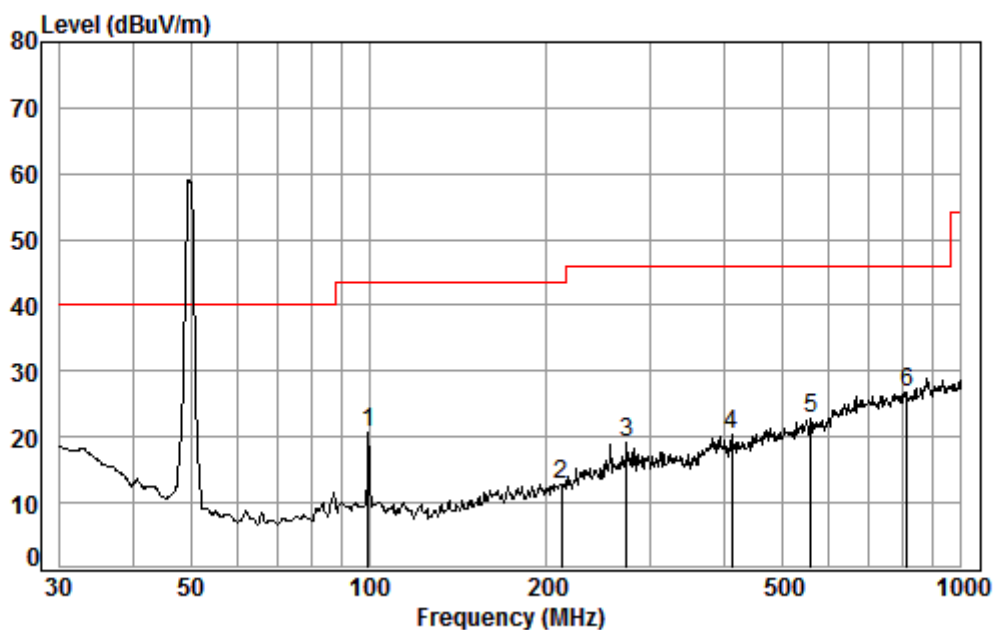

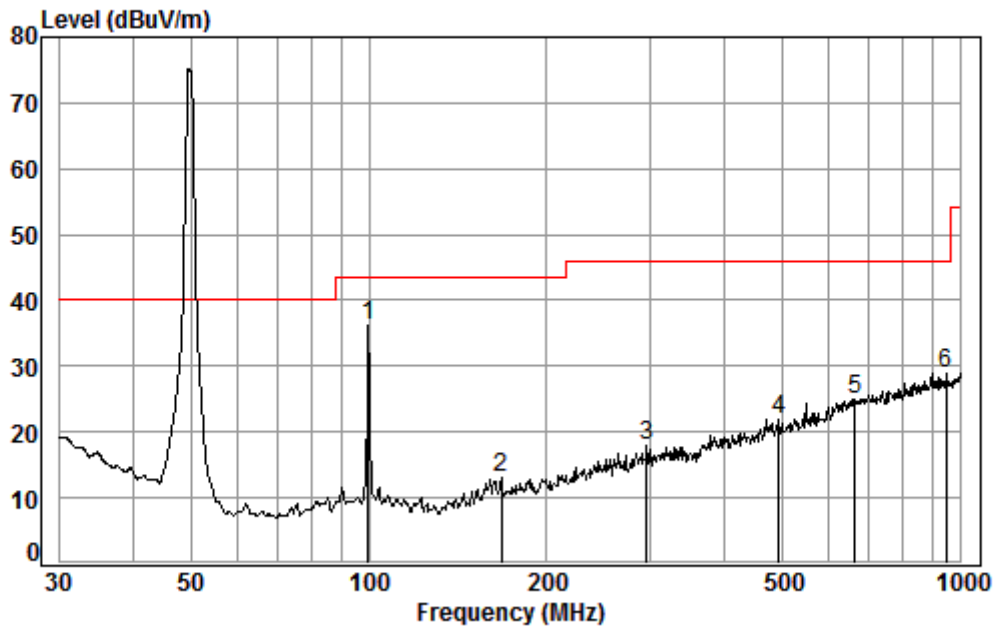

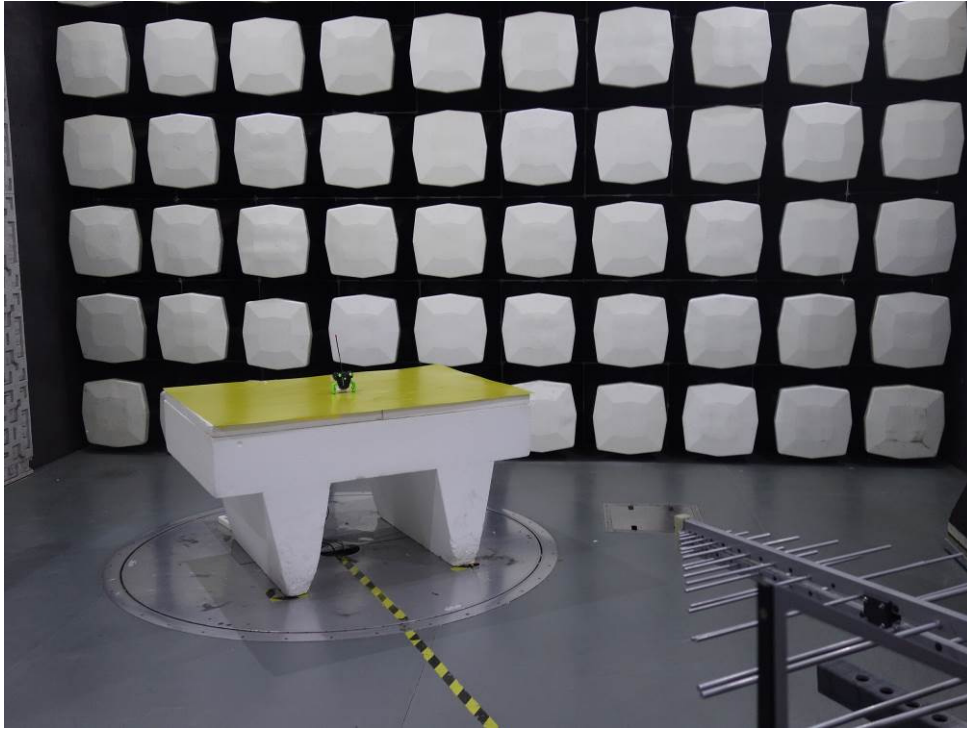
